Mae'r Rheoliadau hyn wedi eu gwneud o ganlyniad i Ddeddf Cymwysterau Cymru 2015 ("Deddf 2015"). Mae Rhan 2 o Ddeddf 2015 yn sefydlu Cymwysterau Cymru ac yn nodi ei brif nodau.

Mae'r Rheoliadau hyn yn diweddu cyfeiriadau mewn deddfwriaeth er mwyn adlewyrchu'r system newydd ar gyfer rheoleiddio cymwysterau y darperir ar chyfer yn Nedd 2015.

Mae'r Rheoliadau hyn yn diwygio deddfwriaeth sylfaenol ac is-ddeddfwriaeth, o ganlyniad i ddarpariaethau Deddf 2015, neu at ddibenion darpariaethau'r Ddeddf honno, sef Rhan 2 (sefydlu a phrif nodau Cymwysterau Cymru), Rhan 3 (cydnabod cyrff dyfarnu), Rhan 6 (darpariaeth bellach sy'n berthnasol i gydnabod, cymeradwyo a dynodi) ac adran 56 (dehongli cyfeiriadau at "cymhwyster") o Ddeddf 2015 ac Atodlen 3 (darpariaeth bellach ynghylch cydnabod cyrff dyfarnu) ac Atodlen 4 (diwygiadau canlyniadol) iddi.

Mae gan Gymwysterau Cymru (sydd wedi ei sefydlu gan adran 2 o'r Ddeddf) swyddogaethau cydnabod cyrff sy'n dyfarnu cymwysterau yng Nghymru (Rhan 3) a rheoleiddio cyrff o'r fath drwy amodau cydnabod (adran 36 ac Atodlen 3). Mae adran 34 yn ymdrin â chymwysterau y caniateir iddynt gael eu defnyddio ar gyrsiau penodol sy'n cael eu cyllido'n gyhoeddus, sydd, yn gyffredinol, yn eu cyfyngu i ffurfiau ar gymhwyster sydd naill ai wedi eu cymeradwyo gan Gymwysterau Cymru (o dan Ran 4) neu wedi eu dynodi ganddo (o dan Ran 5). Mae Atodlen 4 yn diwygio Rhan 5 o Ddeddf Addysg 1997 a Rhan 5 o Ddeddf Dysgu a Sgiliau 2000.

**The Qualifications Wales Act 2015  
(Consequential Amendments)

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations are made in consequence of the Qualifications Wales Act 2015 ("the 2015 Act"). Part 2 of the 2015 Act establishes Qualifications Wales and sets out its principal aims.

These Regulations update references in legislation so as to reflect the new system of qualification regulation provided for in the 2015 Act.

These Regulations make amendments to primary and secondary legislation, which are in consequence of, or for the purposes of, provisions of the 2015 Act, namely Part 2 (establishment and principal aims of Qualifications Wales), Part 3 (recognition of awarding bodies), Part 6 (further provision relevant to recognition, approval and designation), section 56 (interpretation of references to "qualification") of, and Schedule 3 (further provision about recognition of awarding bodies) and Schedule 4 (consequential amendments) to, the 2015 Act.

Qualifications Wales (which is established by section 2 of the Act) has functions of recognising bodies awarding qualifications in Wales (Part 3) and regulating such bodies through conditions of recognition (section 36 and Schedule 3). Section 34 addresses the qualifications which may be used on certain publicly funded courses, which generally limits them to forms of qualification which are either approved by Qualifications Wales (under Part 4) or designated by it (under Part 5). Schedule 4 amends Part 5 of the Education Act 1997 and Part 5 of the Learning and Skills Act 2000.

The Welsh Ministers in exercise of the powers in sections 55(1)(c) and 59 of the Qualifications Wales Act 2015(1) make the following Regulations.

The Welsh Ministers consider it expedient for the purposes of, or in consequence of, provisions of that Act to make the following Regulations.

In accordance with section 55(2) of the Qualifications Wales Act 2015, a draft of these Regulations was laid before the National Assembly for Wales and approved by a resolution of the National Assembly for Wales.

#### Title and commencement

1. The title of these Regulations is the Qualifications Wales Act 2015 (Consequential Amendments) Regulations 2016 and they come into force on 1 May 2016.

**Amendment to the Education (Information About Children in Alternative Provision) (Wales) Regulations 2009**

**11.** In regulation 2 of the Education (Information About Children in Alternative Provision) (Wales) Regulations 2009(2) for the definition of “approved relevant qualification” substitute—

““approved relevant qualification” (“cymhwyster perthnasol a gymeradwywyd”) is a qualification within the meaning of section 56 of the Qualifications Wales Act 2015;”.

**Amendment to the Head Teacher’s Report to Parents and Adult Pupils (Wales) Regulations 2011**

**12.** In regulation 2(1) of the Head Teacher’s Report to Parents and Adult Pupils (Wales) Regulations 2011(3)—

- (a) in the definition of “approved relevant qualification” for “section 30(5) of the Education Act 1997” substitute “section 56 of the Qualifications Wales Act 2015”; and
- (b) in the definition of “NQF” omit the words from “comprising relevant qualifications” to the end.
