

**2017 No. 591 (W. 138)**

**ROAD TRAFFIC, WALES**

**The A40 Trunk Road (Scotchwell  
Roundabout to Rudbaxton Junction,  
Haverfordwest, Pembrokeshire)  
(Temporary Speed Restrictions &  
No Overtaking) Order 2017**

*Made* 18 April 2017

*Coming into force* 24 April 2017

The Welsh Ministers, being the traffic authority for the relevant length of the London – Fishguard Trunk Road (A40) (“the trunk road”), are satisfied that traffic in specified lengths of the trunk road should be restricted and/or prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984<sup>(1)</sup>, make this Order.

**Title, Interpretation and Commencement**

**1.** This Order comes into force on 24 April 2017 and its title is The A40 Trunk Road (Scotchwell Roundabout to Rudbaxton Junction, Haverfordwest, Pembrokeshire) (Temporary Speed Restrictions & No Overtaking) Order 2017.

**2.—(1)** In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means:

(a) any vehicle being used by the emergency services; and

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (*“lluoedd arbennig”*) means those units of the home forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the lengths of the trunk road” (*“y darnau o’r gefnffordd”*) means the lengths of the trunk road at Haverfordwest in the County of Pembrokeshire specified in the Schedules to this Order;

“works period” (*“cyfnod y gwaith”*) means the period commencing at 00:01 hours on 24 April 2017 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

### **Restrictions & Prohibition**

**3.** No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the lengths of the trunk road specified in Schedule 1.

**4.** No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the lengths of the trunk road specified in the Schedules.

**5.** No person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the lengths of the trunk road specified in the Schedules during such times as the restriction referred to in article 4 is in operation.

### **Suspensions**

**6.** Any statutory provisions restricting the speed of vehicles on the relevant lengths of the trunk road specified in the Schedules are suspended during such times as the restrictions specified in articles 3 and 4 are in operation.

## **Application**

7.—(1) The restrictions and prohibition in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

## **Duration of this Order**

8. The maximum duration of this Order shall be 18 months.

## **SCHEDULES**

### **SCHEDULE 1**

#### **Temporary 40 mph or 10 mph Speed Limit & No Overtaking**

The length of the trunk road that extends from a point 117 metres north of its junction with Scotchwell Roundabout to a point 116 metres south of its junction with Withybush Roundabout, Haverfordwest, including the circulatory carriageway of Cardigan Road Roundabout.

The length of the trunk road that extends from a point 103 metres north of its junction with Withybush Roundabout, Haverfordwest to its junction with the road leading to Rudbaxton.

### **SCHEDULE 2**

#### **Temporary 10 mph Speed Limit & No Overtaking**

The length of the trunk road that extends from its junction with Scotchwell Roundabout, Haverfordwest to a point 117 metres north of that junction.

The length of the trunk road that extends from a point 116 metres south of its junction with Withybush Roundabout, Haverfordwest to a point 103 metres north of its junction with that roundabout, including the circulatory carriageway of the roundabout.
