Regulation 5

Provision of Information by Schools and Local Authorities

1. The person's—
 - (a) gender;
 - (b) date of birth;
 - (c) national insurance number;
 - (d) full name;
 - (e) ethnic group (if known);
 - (f) whether the person has a disability within the meaning of section 6(1) of the Equality Act 2010(1) (if known); and
 - (g) official reference number assigned by the Council, where such a number is held(2).

2. The post held by the person and the role or roles the person carries out.

 - [^{F4}(d) whether P teaches areas of learning and experience through the medium of Welsh, other than the mandatory element of Welsh;]

(4) For school teachers the current applicable pay ranges are set out in the Document and are the leadership pay range (see section 9 of the Document), main pay range (see section 13 of the Document), upper pay range (see 14 section of the Document), leading practitioner pay range (see section 16 of the Document) or unqualified teacher pay range (section 17 of the Document). In respect of school learning support workers the pay range will be determined by the employer who may be either the local authority which maintains the school, or the governing body of the school where the person works.

(5) Paragraph 43 of the Document published by the Department for Education in September 2016 states that teachers employed on a day-to-day or other short notice basis must be paid in accordance with the provisions of the Document on a daily basis calculated on the assumption that a full working year consists of 195 days, periods of employment for less than a day being calculated pro rata. The Document is updated by the Secretary of State annually.
