Mae'r Rheoliadau hyn yn rhagnodi'r gyfradd safonol, y gyfradd is a'r gyfradd gwarediadau sydd heb eu hawdurdodi ar gyfer y dreth gwarediadau tirlenwi sydd i'w chodi ar warediadau trethadwy a wneir ar 1 Ebrill 2019 neu ar ôl hynny.

These Regulations prescribe the standard rate, lower rate and unauthorised disposals rate for landfill disposals tax chargeable on taxable disposals made on or after 1 April 2019.

Y gyfradd safonol yw £91.35 y dunnell, y gyfradd is yw £2.90 y dunnell a'r gyfradd gwarediadau sydd heb eu hawdurdodi yw £137.00 y dunnell.

The standard rate is £91.35 per tonne, the lower rate is £2.90 per tonne and the unauthorised disposals rate is £137.00 per tonne.

Bydd gwarediadau trethadwy a wneir cyn 1 Ebrill 2019 yn parhau'n ddarostyngedig i'r cyfraddau a osodir gan Reoliadau Treth Gwarediadau Tirlenwi (Cyfraddau Treth) (Cymru) 2018 (O.S. 2018/131 (Cy. 33)) o ganlyniad i'r diwygiad a wneir gan reoliad 4 o'r Rheoliadau hyn.

Taxable disposals made before 1 April 2019 will remain subject to rates set by the Landfill Disposals Tax (Tax Rates) (Wales) Regulations 2018 (S.I. 2018/131 (W. 33)) as a result of the amendment made by regulation 4 of these Regulations.

The Welsh Ministers make the following Regulations in exercise of the powers conferred on them by sections 14(3) and (6), 46(4) and 94(1) of the Landfill Disposals Tax (Wales) Act 2017(1).

Enwi a chychwyn

1. Enw'r Rheoliadau hyn yw Rheoliadau Treth Gwarediadau Tirlenwi (Cyfraddau Treth) (Cymru) (Diwygio) 2018 a deuant i rym ar 1 Ebrill 2019.

Title and commencement

1. The title of these Regulations is the Landfill Disposals Tax (Tax Rates) (Wales) (Amendment) Regulations 2018 and they come into force on 1 April 2019.

Cymhwyso

2. Mae'r Rheoliadau hyn yn cael effaith mewn perthynas â gwarediad trethadwy a wneir ar 1 Ebrill 2019 neu ar ôl hynny.

Application

2. These Regulations have effect in relation to a taxable disposal made on or after 1 April 2019.

Cyfraddau'r dreth gwarediadau tirlenwi

3. Rhagnodir y cyfraddau a ganlyn yn unol ag adrannau 14(3) a (6), a 46(4) o Ddeddf Treth Gwarediadau Tirlenwi (Cymru) 2017—

- (a) y gyfradd safonol yw £91.35 y dunnell;
- (b) y gyfradd is yw £2.90 y dunnell; ac

Rates of landfill disposals tax

3. The following rates are prescribed in accordance with sections 14(3) and (6), and 46(4) of the Landfill Disposals Tax (Wales) Act 2017—

- (a) the standard rate is £91.35 per tonne;
- (b) the lower rate is £2.90 per tonne; and

(c) y gyfradd gwarediadau sydd heb eu hawdurdodi yw £137.00 y dunnell.

(c) the unauthorised disposals rate is £137.00 per tonne.
