ENFORCEMENT AND OFFENCES

[^{F1}Offences: [^{F2}assimilated] pig provisions]

27.—(1) Any person who—

- (a) fails to comply with any requirement under a [^{F3}assimilated] pig provision; or
- (b) contravenes any prohibition contained in a [^{F4}assimilated] pig provision,

is guilty of an offence.

(2) But where an operator or the person responsible for the classification of pig carcases draws up a record in compliance with the conditions referred to in regulation 15 (records instead of marking) no offence is committed by failure to comply with or contravening a Part 2 [^{F5}assimilated] pig provision.

(3) In this regulation, "Part 2 [^{F6}assimilated] pig provision" means a provision which is specified in column (2) of Part 2 of Schedule 2.
