## The Carcase Classification and Price Reporting (Wales) Regulations 2018

### PART 5

#### ENFORCEMENT AND OFFENCES

#### [<sup>F1</sup>Offences: [<sup>F2</sup>assimilated] pig provisions ]

27.—(1) Any person who—

- (a) fails to comply with any requirement under a [<sup>F3</sup>assimilated] pig provision; or
- (b) contravenes any prohibition contained in a [<sup>F4</sup>assimilated] pig provision,

is guilty of an offence.

(2) But where an operator or the person responsible for the classification of pig carcasses draws up a record in compliance with the conditions referred to in regulation 15 (records instead of marking) no offence is committed by failure to comply with or contravening a Part 2 [<sup>F5</sup>assimilated] pig provision.

(3) In this regulation, “Part 2 [<sup>F6</sup>assimilated] pig provision” means a provision which is specified in column (2) of Part 2 of Schedule 2.
