The Education (Student Support) (Wales) Regulations 2018

PART 12

QUALIFYING FOR SUPPORT DURING THE ACADEMIC YEAR

Qualifying for grants or maintenance loan during the academic year

81.—(1) Where one of the events in paragraph (3) occurs, the eligible student may qualify for a grant or maintenance loan.

(2) But the amount of grant or loan payable to the eligible student—

- [^{F1}(a) will only, in the case of a grant, be in respect of the remaining days of the academic year, and, in the case of a maintenance loan, only be in respect of the remaining term days of the academic year, in either case beginning with the day the relevant event occurs, and]
- (b) in relation to a maintenance loan, will only be payable if it is a quarter in respect of which the loan would otherwise be payable under regulation 85(6) and (7).

(3) The events are—

- (a) the student's course becomes a designated course;
- (b) the student becomes an eligible student on the grounds that—
 - [^{F2}(i) the student or the student's spouse, civil partner or parent is recognised as a refugee, becomes a person granted stateless leave, becomes a person with leave to enter or remain or becomes a person granted humanitarian protection under paragraph 339C of the immigration rules;]
 - [^{F3}(ia) the student or the student's parent becomes a person with section 67 leave to remain [^{F4}or a person with leave to remain as a protected partner];]
 - [^{F5}(ib) the student becomes a person with Calais leave;]
 - [^{F6}(ic) the student becomes a person with leave to enter or remain as a relevant Afghan citizen [^{F7}or the spouse, civil partner, child or stepchild of such a person];]
 - [^{F8}(id) the student becomes a protected Ukrainian national [^{F9}or the spouse, civil partner, child or stepchild of such a person];]
 - [^{F10}(ii)]
 - [^{F11}(iii) the student becomes a person described in paragraph 1(2)(a) of Schedule 2;]
 - [^{F12}(iv) where regulation 9(1A)(a) applies, [^{F13}the student becomes a person] described in paragraph 8(1)(a) of Schedule 2;]
 - (v) the student becomes a person described in [^{F14}paragraph 4A(1)(a) of Schedule 2 or, where regulation 9(1A)(a) applies, in] paragraph 4(1)(a) of Schedule 2;
 - [^{F15}(vi) the student becomes a person described in paragraph 7A(a) of Schedule 2 or, where regulation 9(1A)(a) applies, in paragraph 7(1)(a) of Schedule 2;]
