#### **Amendment to the Local Authorities (Executive Arrangements) (Functions and Responsibilities) (Wales) Regulations 2007**

3. In Part D of Schedule 1 (functions not to be the responsibility of an authority's executive) to the Local Authorities (Executive Arrangements) (Functions and Responsibilities) (Wales) Regulations 2007 <sup>M1</sup>, omit paragraph 7.

#### **Amendment to the Local Authorities (Conduct of Referendums) (Wales) Regulations 2008**

4.—(1) The Local Authorities (Conduct of Referendums) (Wales) Regulations 2008 <sup>M2</sup> are amended as follows.

(2) In regulation 2(1), omit the definitions of “European Parliamentary election” (“*etholiad Senedd Ewrop*”) and “European Parliamentary general election” (“*etholiad cyffredinol Senedd Ewrop*”) <sup>M3</sup>.

(3) In Table 5 (The Representation of the People (England and Wales) Regulations 2001 <sup>M4</sup>) of Schedule 4 (application, with modifications, of acts and subordinate legislation), in the row providing for the modification of Schedule 3, Form E <sup>M5</sup>—

- (a) for “For “European Parliamentary electoral region” substitute “ Referendum voting area... ”.” substitute “After “Local government electoral area(s)” insert “ Referendum voting area... ”.”;
- (b) for “to “electoral region]]”” substitute “ to “electoral area]]” ”.
