Mae'r Rheoliadau hyn yn diwygio Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd Deintyddol) (Cymru) 2006 (O.S. 2006/491 (Cy. 60)) ("Rheoliadau 2006").

Mae rheoliad 2 yn diwygio rheoliad 4 o Rheoliadau 2006 (cyfrifo ffioedd) drwy gynyddu'r ffi gymwysadwy sydd i'w thalu am gwrs o driniaeth Band 1, Band 2 a Band 3.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the National Health Service (Dental Charges) (Wales) Regulations 2006 (S.I. 2006/491 (W. 60)) ("the 2006 Regulations").

Regulation 2 amends regulation 4 of the 2006 Regulations (calculation of charges) by increasing the applicable charge payable for a Band 1, a Band 2 and a Band 3 course of treatment.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

1. Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd Deintyddol) (Cymru) (Diwygio) 2019 a deuant i rym ar 1 Ebrill 2019.

**Title and commencement**

1. The title of these Regulations is the National Health Service (Dental Charges) (Wales) (Amendment) Regulations 2019 and they come into force on 1 April 2019.
