EXPLANATORY NOTE

(This note is not part of the Order)

This Order designates the area described in the Schedule to this Order as a civil enforcement area for parking contraventions and a special enforcement area for the purposes of Part 6 of the Traffic Management Act 2004. This Order enables Monmouthshire County Council to enforce parking contraventions within the area described in the Schedule to this Order through a civil law regime, as opposed to enforcement by police or traffic wardens in a criminal law context.

Mae'r Gorchymyn hwn wedi ei wneud gan Weinidogion Cymru(1) drwy arfer y pwerau a roddir i Gynulliad Cenedlaethol Cymru gan baragraff 8(1) o Atodlen 8 a pharagraff 3(1) o Atodlen 10 i Ddeddf Rheoli Traffig 2004(2).

This Order is made by the Welsh Ministers(1) in exercise of the powers conferred on the National Assembly for Wales by paragraph 8(1) of Schedule 8 and paragraph 3(1) of Schedule 10 to the Traffic Management Act 2004(2).

Mae Cyngor Sir Fynwy wedi gwneud cais i Weinidogion Cymru i Orchymyn gael ei wneud o dan y pwerau hyn mewn cysylltiad â rhan o ardal y Cyngor hwnnw.

Monmouthshire County Council has applied to the Welsh Ministers for an Order to be made under these powers in respect of part of that Council's area.

Mae Gweinidogion Cymru wedi ymgynghori â phrif swyddog Heddlu Gwent yn unol â gofynion paragraff 8(3) o Atodlen 8 a pharagraff 3(4) o Atodlen 10 i Ddeddf Rheoli Traffig 2004.

The Welsh Ministers have consulted the chief officer of Gwent Police in accordance with the requirements of paragraph 8(3) of Schedule 8 and paragraph 3(4) of Schedule 10 to the Traffic Management Act 2004.

2. The Welsh Ministers designate the area described in the Schedule to this Order as—

- (a) a civil enforcement area for parking contraventions; and
- (b) a special enforcement area.

Area designated as a civil enforcement area for parking contraventions and a special enforcement area

Ardal Sir Fynwy (“y Sir”) ac eithrio—

The area of the County of Monmouthshire (“the County”) with the exception of—

- (a) y darn o Draffordd yr M4 o fewn y Sir, o'r ffin â Dinas Casnewydd hyd at y ffin wrth Bont Tywysog Cymru, gan gynnwys ei ffyrdd ymadael ac ymuno;
- (b) y darn o Draffordd yr M48 o fewn y Sir, o'i chyffordd â Thraffordd yr M4 hyd at y ffin â Phont Afon Gwy, gan gynnwys ei ffyrdd ymadael ac ymuno;
- (c) y darn o Gefnffordd yr A40 o fewn y Sir, o'i chyffordd â Chefnffordd yr A465 hyd at y ffin â Sir Powys ac o'i chyffordd â Chefnffordd yr A465 hyd at y ffin â Swydd Henffordd, gan gynnwys ei ffyrdd ymadael ac ymuno;

- (a) the length of the M4 Motorway within the County, from the boundary with the City of Newport to the boundary at the Prince of Wales Bridge, including its exit and entry slip roads;
- (b) the length of the M48 Motorway within the County, from its junction with the M4 Motorway to the boundary at the Wye Bridge, including its exit and entry slip roads;
- (c) the length of the A40 Trunk Road within the County, from its junction with the A465 Trunk Road to the boundary with the County of Powys and from its junction with the A465 Trunk Road to the boundary with the County of Herefordshire, including its exit and entry slip roads;

- (d) y darn o Gefnffordd yr A465 o fewn y Sir, o'i chyffordd â Chefnffordd yr A40 hyd at y ffin â Bwrdeistref Sirol Blaenau Gwent ac o'i chyffordd â Chefnffordd yr A40 hyd at y ffin â Swydd Henffordd, gan gynnwys ei ffyrdd ymadael ac ymuno;
- (e) y darn o Gefnffordd yr A449 o fewn y Sir, o'r ffin â Dinas Casnewydd hyd at ei chyffordd â Chefnffordd yr A40, gan gynnwys ei ffyrdd ymadael ac ymuno;
- (f) y darn o Gefnffordd yr A4042 o fewn y Sir, o'r ffin â Bwrdeistref Sirol Torfaen hyd at ei chyffordd â Chefnffordd yr A465;
- (g) y darn o Gefnffordd yr A466 o fewn y Sir, o'i chyffordd â thraffordd yr M48 hyd at ei chyffordd â Chefnffordd yr A48; ac
- (h) y darn o Gefnffordd yr A48 o fewn y Sir, o'i chyffordd â Chefnffordd yr A466 hyd at y ffin â Swydd Gaerloyw.

- (d) the length of the A465 Trunk Road within the County, from its junction with the A40 Trunk Road to the boundary with the County Borough of Blaenau Gwent and from its junction with the A40 Trunk Road to the boundary with the County of Herefordshire, including its exit and entry slip roads;
- (e) the length of the A449 Trunk Road within the County, from the boundary with the City of Newport to its junction with the A40 Trunk Road, including its exit and entry slip roads;
- (f) the length of the A4042 Trunk Road within the County, from the boundary with the County Borough of Torfaen to its junction with the A465 Trunk Road;
- (g) the length of the A466 Trunk Road within the County, from its junction with the M48 motorway to its junction with A48 Trunk Road; and
- (h) the length of the A48 Trunk Road within the County, from its junction with the A466 Trunk Road to the boundary with the County of Gloucestershire.
