Mae'r Rheoliadau hyn wedi eu gwneud drwy arfer y pwerau a roddir gan baragraff 1(1) o Atodlen 2 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (p. 16) er mwyn ymdrin ag unrhyw fethiant yng nghyfraith yr UE a ddargedwir i weithredu'n effeithiol a diffygion eraill sy'n deillio o ymadawiad y Deyrnas Unedig â'r Undeb Ewropeaidd.

These Regulations are made in exercise of the powers conferred by paragraph 1(1) of Schedule 2 to the European Union (Withdrawal) Act 2018 (c. 16) in order to address failures of retained EU law to operate effectively and other deficiencies arising from the withdrawal of the United Kingdom from the European Union.

Mae'r Rheoliadau hyn yn diwygio is-ddeddfwriaeth, sy'n gymwys o ran Cymru, ym meysydd cofnodi, adnabod a symud da byw.

These Regulations make amendments to subordinate legislation, which apply in relation to Wales, in the fields of the recording, identification and movement of livestock.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers conferred by paragraph 1(1) of Schedule 2 to the European Union (Withdrawal) Act 2018(1), make the following Regulations.

The requirements of paragraph 4(2) of Schedule 7 to the European Union (Withdrawal) Act 2018 (relating to the appropriate National Assembly for Wales scrutiny procedure for these Regulations) have been satisfied.

Title, commencement and application

1.—(1) The title of these Regulations is the Livestock (Records, Identification and Movement) (Miscellaneous Amendments) (Wales) (EU Exit) Regulations 2019.

Rheoliadau Adnabod Gwartheg (Cymru) 2007

2.—(1) Mae Rheoliadau Adnabod Gwartheg (Cymru) 2007(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2(1), ym mharagraff (a) o'r diffiniad o "pasbort gwartheg" yn lle "yng Nghymru, Lloegr neu'r Alban o dan Erthygl 6(1) o Reoliad (EC) Rhif 1760/2000" rhodder "o dan Atodlen 3 i'r Rheoliadau hyn, neu'r mesur cyfatebol yn Lloegr neu'r Alban".

(3) Yn rheoliad 10(3)(f), yn lle "â chynrychiolydd o'r Comisiwn Ewropeaidd neu unrhyw berson arall" rhodder "ag unrhyw berson".

(4) Yn Atodlen 1, hepgorer paragraff 8.

(5) Ym mharagraff 4 o Atodlen 2, yn y teitl ac yn is-baragraff (1), hepgorer "arall".

Gorchymyn Moch (Cofnodion, Adnabod a Symud) (Cymru) 2011

3.—(1) Mae Gorchymyn Moch (Cofnodion, Adnabod a Symud) (Cymru) 2011(2) wedi ei ddiwygio fel a ganlyn.

(2) Yn erthygl 8(2)(c), yn lle "masnachu neu allforio o fewn y Gymuned" rhodder "allforio".

(3) Yn erthygl 10, yn lle "masnachu neu allforio o fewn y Gymuned" rhodder "allforio".

Gorchymyn Defaid a Geifr (Cofnodion, Adnabod a Symud) (Cymru) 2015

4.—(1) Mae Gorchymyn Defaid a Geifr (Cofnodion, Adnabod a Symud) (Cymru) 2015(3) wedi ei ddiwygio fel a ganlyn.

(2) Yn erthygl 2(1), yn y diffiniadau o "allforio", "marc adnabod" a "dull adnabod", hepgorer "arall".

(3) Yn erthygl 32, yn y teitl ac ym mharagraffau (1) a (2), hepgorer "arall".

(4) Yn erthygl 38(1)(g), hepgorer "â chynrychiolydd o'r Comisiwn Ewropeaidd gydag ef sy'n gweithredu at ddibenion Erthygl 12 o Reoliad y Cyngor, neu fynd".

(5) Yn erthygl 41(d), hepgorer "arall".

(2) These Regulations come into force on exit day.

(3) These Regulations apply in relation to Wales.

The Cattle Identification (Wales) Regulations 2007

2.—(1) The Cattle Identification (Wales) Regulations 2007(1) are amended as follows.

(2) In regulation 2(1), in paragraph (a) of the definition of "cattle passport" for "in England, Wales or Scotland under Article 6(1) of Regulation (EC) No 1760/2000" substitute "under Schedule 3 to these Regulations or the equivalent measure in England or Scotland".

(3) In regulation 10(3)(h), for "a representative of the European Commission or any other" substitute "any".

(4) In Schedule 1, omit paragraph 8.

(5) In paragraph 4 of Schedule 2, in the title and in sub-paragraph (1), for "another" substitute "a".

The Pigs (Records, Identification and Movement) (Wales) Order 2011

3.—(1) The Pigs (Records, Identification and Movement) (Wales) Order 2011(2) is amended as follows.

(2) In article 8(2)(c), omit "intra-Community trade or".

(3) In article 10, omit "intra-Community trade or".

The Sheep and Goats (Records, Identification and Movement) (Wales) Order 2015

4.—(1) The Sheep and Goats (Records, Identification and Movement) (Wales) Order 2015(3) is amended as follows.

(2) In article 2(1), in the definitions of "export", "identification mark", and "method of identification", for "another" substitute "a".

(3) In article 32, in the title and in paragraphs (1) and (2), for "another" substitute "a".

(4) In article 38(1)(g), omit "a representative of the European Commission acting for the purposes of Article 12 of the Council Regulation, or".

(5) In article 41(d), for "another" substitute "a".

(1) O.S. 2007/842 (Cy. 74), a ddiwygiwyd gan O.S. 2013/821 (Cy. 97); mae offerynnau diwygio eraill ond nid yw'r un ohonynt yn berthnasol.

(2) O.S. 2011/2830 (Cy. 303), y mae diwygiadau iddo nad ydynt yn berthnasol i'r Rheoliadau hyn.
