Mae adran 145(1) o Ddeddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 (dccc 4) (“Deddf 2014”) yn galluogi Gweinidogion Cymru i ddyroddi codau ar arfer swyddogaethau gwasanaethau cymdeithasol. Mae adran 145(3) o Ddeddf 2014 yn ei gwneud yn ofynnol i awdurdodau lleol, wrth arfer swyddogaethau gwasanaethau cymdeithasol, weithredu yn unol ag unrhyw ofynion perthnasol sydd wedi eu cynnwys mewn cod a rhoi sylw i unrhyw ganllawiau perthnasol sydd wedi eu cynnwys yn y cod.

Mae Rheoliadau Gwasanaethau Maethu Awdurdodau Lleol (Cymru) 2018 (O.S. 2018/1339 (Cy. 261)) (“y Rheoliadau”) (fel y’u diwygiwyd gan Reoliadau Gwasanaethau Maethu Awdurdodau Lleol (Cymru) (Diwygio) 2019 (O.S. 2019/545 (Cy. 119)) yn gosod gofynion ar ddarparwyr a rheolwyr gwasanaethau maethu awdurdodau lleol mewn perthynas â darparu gwasanaethau maethu.

Mae’r cod ymarfer mewn perthynas â gwasanaethau maethu awdurdodau lleol (“y cod”) yn nodi canllawiau ar sut y caiff darparwyr a rheolwyr gwasanaethau maethu awdurdodau lleol gydymffurfio â’r gofynion a osodir gan y Rheoliadau. Dyroddwyd y cod gan Weinidogion Cymru ar 17 Mai 2019. Mae’r Gorchymyn hwn yn penodi 20 Mai 2019 fel y diwrnod y daw’r cod i rym.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

Section 145(1) of the Social Services and Well-being (Wales) Act 2014 (anaw 4) (“the 2014 Act”) enables the Welsh Ministers to issue codes on the exercise of social services functions. Section 145(3) of the 2014 Act requires local authorities, when exercising social services functions, to act in accordance with any relevant requirements contained in a code and to have regard to any relevant guidelines contained in the code.

The Local Authority Fostering Services (Wales) Regulations 2018 (S.I. 2018/1339 (W. 261)) (“the Regulations”) (as amended by the Local Authority Fostering Services (Wales) (Amendment) Regulations 2019 (S.I. 2019/545 (W. 119)) impose requirements on local authority fostering services providers and managers in relation to the provision of fostering services.

The code of practice in relation to local authority fostering services (“the code”) sets out guidance on how local authority fostering services providers and managers may comply with the requirements imposed by the Regulations. The code was issued by the Welsh Ministers on 17 May 2019. This Order appoints 20 May 2019 as the day on which the code comes into force.
