**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations are made in exercise of the  
powers conferred by section 3(3)(a) of the Direct  
Payments to Farmers (Legislative Continuity) Act  
2020 (c. 2) in order to address failures of retained EU  
law governing the Common Agricultural Policy Direct  
Payment Schemes to operate effectively, and  
deficiencies in that retained EU law.

The Welsh Ministers' Code of Practice on the  
carrying out of Regulatory Impact Assessments was  
considered in relation to these Regulations. As a result,  
it was not considered necessary to carry out a  
regulatory impact assessment as to the likely costs and  
benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers  
conferred by section 3(3)(a) of the Direct Payments to  
Farmers (Legislative Continuity) Act 2020(1), make  
the following Regulations.

**Title and commencement**

1.—(1) The title of these Regulations is the Common  
Agricultural Policy (Direct Payments to Farmers)  
(Miscellaneous Amendments) (Wales) Regulations  
2020.

(2) These Regulations come into force on exit day  
and paragraph 1(1) of Schedule 5 to the European  
Union (Withdrawal Agreement) Act 2020(2) does not  
apply.

2.—(1) Mae Rheoliadau'r Polisi Amaethyddol Cyffredin (System Integredig Gweinyddu a Rheoli a Gorfodi a Thrawsgydymffurfio) (Cymru) 2014(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2—

(a) ym mharagraff (1), yn lle'r diffiniad o "taliadau uniongyrchol" rhodder—

"mae i "taliadau uniongyrchol" yr ystyr a roddir i "direct payments" gan Erthygl 1 o'r Rheoliad Taliadau Uniongyrchol.";

(b) ar ôl paragraff (1) mewnosoder—

"(1A) Mae cyfeiriadau yn y Rheoliadau hyn at y Rheoliad Dirprwyedig Llorweddol, y Rheoliad Gweithredu Llorweddol a'r Rheoliad Llorweddol, i'r graddau y maent yn ymwneud â'r taliadau uniongyrchol ar gyfer blwyddyn hawlio 2020, yn gyfeiriadau at y Rheoliadau hynny fel y maent yn bodoli mewn cyfraith ddomestig."

(3) Yn rheoliad 7, ym mharagraff (7)(a), ar y dechrau mewnosoder "ac eithrio materion sy'n ymwneud â thaliadau uniongyrchol ar gyfer blwyddyn hawlio 2020,".

## Rheoliadau Cynllun Taliad Sylfaenol a Chynlluniau Cymorth y Polisi Amaethyddol Cyffredin (Cymru) 2015

3.—(1) Mae Rheoliadau Cynllun Taliad Sylfaenol a Chynlluniau Cymorth y Polisi Amaethyddol Cyffredin (Cymru) 2015(2) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 3—

(a) hepgorwr "a (2)", a

(b) yn lle "Erthygl 10(1)(b)" rhodder "Erthygl 10(1)".

(3) Yn rheoliad 7, hepgorwr "a (2)(c)".

## The Common Agricultural Policy (Integrated Administration and Control System and Enforcement and Cross Compliance) (Wales) Regulations 2014

2.—(1) The Common Agricultural Policy (Integrated Administration and Control System and Enforcement and Cross Compliance) (Wales) Regulations 2014(1) are amended as follows.

(2) In regulation 2—

(a) in paragraph (1), for the definition of "direct payments" substitute—

"“direct payments” (“*taliadau uniongyrchol*”) has the meaning given by Article 1 of the Direct Payments Regulation;”;

(b) after paragraph (1) insert—

"(1A) References in these Regulations to the Horizontal Delegated Regulation, the Horizontal Implementing Regulation and the Horizontal Regulation are, to the extent that they relate to the direct payments for claim year 2020, references to those Regulations as they exist in domestic law."

(3) In regulation 7, in paragraph (7)(a), at the beginning insert "except for matters relating to direct payments for claim year 2020,".

## The Common Agricultural Policy Basic Payment and Support Schemes (Wales) Regulations 2015

3.—(1) The Common Agricultural Policy Basic Payment and Support Schemes (Wales) Regulations 2015(2) are amended as follows.

(2) In regulation 3—

(a) omit "and (2)", and

(b) for "Article 10(1)(b)" substitute "Article 10(1)".

(3) In regulation 7, omit "and (2)(c)".
