Mae'r Rheoliadau hyn wedi eu gwneud drwy arfer y pŵer a roddir gan baragraff 11M(1) o Atodlen 2 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (p. 16). Mae'r Protocol ar Iwerddon/Gogledd Iwerddon yn y cytundeb ymadael yn ei gwneud yn ofynnol i ddeddfwriaeth yr UE a restrir yn Atodiad 2 i'r Protocol hwnnw gael ei gweithredu yng Ngogledd Iwerddon. Mae'r Rheoliadau hyn, felly, yn diwygio Rheoliadau Adnabod Ceffylau (Cymru) (Diwygio) (Ymadael â'r UE) 2019 (O.S. 2019/250 (Cy. 62)) er mwyn gweithredu'r Protocol ar Iwerddon/Gogledd Iwerddon ac at ddibenion ymdrin â materion sy'n codi o'r Protocol hwnnw neu sy'n gysylltiedig ag ef.

These Regulations are made in exercise of the power conferred by paragraph 11M(1) of Schedule 2 to the European Union (Withdrawal) Act 2018 (c. 16). The Protocol on Ireland/Northern Ireland in the withdrawal agreement requires that the EU legislation listed in Annex 2 to that Protocol is implemented in Northern Ireland. These Regulations therefore amend the Equine Identification (Wales) (Amendment) (EU Exit) Regulations 2019 (S.I. 2019/250 (W. 62)) in order to implement the Protocol on Ireland/Northern Ireland and for the purposes of dealing with matters arising out of, or related to, that Protocol.

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Adnabod Ceffylau (Cymru) (Diwygio) (Ymadael â'r UE) 2019, sy'n gwneud diwygiadau i Reoliadau Adnabod Ceffylau (Cymru) 2019 (O.S. 2019/57 (Cy. 20)) er mwyn ymdrin ag unrhyw fethiant yng nghyfraith yr UE a ddargedwir i weithredu'n effeithiol a diffygion eraill sy'n deillio o ymadawiad y Deyrnas Unedig â'r Undeb Ewropeaidd.

These Regulations amend the Equine Identification (Wales) (Amendment) (EU Exit) Regulations 2019, which make amendments to the Equine Identification (Wales) Regulations 2019 (S.I. 2019/57 (W. 20)) to address failures of retained EU law to operate effectively and other deficiencies arising from the withdrawal of the United Kingdom from the European Union.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers conferred by paragraph 11M(1) of Schedule 2 to the European Union (Withdrawal) Act 2018(1), make the following Regulations.

Title and commencement

1.—(1) The title of these Regulations is the Equine Identification (Wales) (Amendment) (EU Exit) Regulations 2020.

(2) These Regulations come into force immediately before implementation period completion day.

**Amendment of the Equine Identification (Wales)
(Amendment) (EU Exit) Regulations 2019**

2.—(1) Regulation 2 of the Equine Identification (Wales) (Amendment) (EU Exit) Regulations 2019(2) is amended as follows.

(1) 2018 c. 16; paragraph 11M of Schedule 2 to the 2018 Act was inserted by section 22 of the European Union (Withdrawal Agreement) Act 2020 (c. 1); there are other amendments not relevant to these Regulations. See section 20(1) of the 2018 Act for the definition of "devolved authority".

(2) S.I. 2019/250 (W. 62).

(2) Ym mharagraff (3), yn lle'r testun a amnewidiwyd rhodder "i Brydain Fawr o wlad heblaw Gogledd Iwerddon neu Aelod-wladwriaeth".

(3) Yn lle paragraff (4) rhodder—

“(4) Yn rheoliad 13(3)(b), yn lle “Aelod-wladwriaeth arall” rhodder “Aelod-wladwriaeth neu Ogledd Iwerddon”.”

(2) In paragraph (3), for the substituted text substitute “Great Britain from a country other than Northern Ireland or a member State”.

(3) For paragraph (4) substitute—

“(4) In regulation 13(3)(b), for “another member State” substitute “a member State or Northern Ireland”.”
