Mae'r Gorchymyn hwn wedi ei wneud o dan adran 2 o Ddeddf Addysg 2002. Mae erthygl 2 yn darparu nad yw rheoliad 4(2), (3) a (4) o Reoliadau Newid Amserau Sesiynau Ysgolion (Cymru) 2009 yn gymwys i gorff llywodraethu Ysgol Gynradd yr Eglwys yng Nghymru y Trallwng. Bydd hyn yn caniatáu i'r corff llywodraethu wneud newidiadau i ba bryd y mae sesiynau'r ysgol yn dechrau ac yn dod i ben, gan gynnwys pa bryd y mae'r diwrnod ysgol yn dechrau ac yn dod i ben, o 1 Ionawr 2021 ymlaen, yn hytrach nag ar ddechrau tymor ysgol neu flwyddyn ysgol. Mae erthygl 3 yn pennu bod y Gorchymyn yn cael effaith tan 31 Awst 2021.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

EXPLANATORY NOTE

(*This note is not part of the Order*)

This Order is made under section 2 of the Education Act 2002. Article 2 provides that regulation 4(2), (3) and (4) of the Changing of School Session Times (Wales) Regulations 2009 does not apply to the governing body of Welshpool Church in Wales Primary School. This will allow the governing body to make alterations to when the school sessions start and end, including when the school day starts and ends, from 1 January 2021, rather than at the beginning of a school term or school year. Article 3 specifies that the Order has effect until 31 August 2021.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

Mae Gweinidogion Cymru o’r farn, ar ôl rhoi sylw i’r materion a nodir yn adran 1(2) o’r Ddeddf, y gall gweithredu gan y corff llywodraethu ddarpariaethau’r Gorchymyn hwn gyfrannu at godi’r safonau addysgol a gyrhaeddir gan blant yng Nghymru;

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir i Gynulliad Cenedlaethol Cymru gan adran 2(1) o’r Ddeddf(2), ac a freiniwyd bellach ynddynt hwy, ar gais y corff llywodraethu, yn gwneud y Gorchymyn a ganlyn:

The Welshpool Church in Wales Primary School (Change to School Session Times) Order 2020

Made 24 November 2020

Laid before Senedd Cymru 25 November 2020

Coming into force 1 January 2021

The governing body of Welshpool Church in Wales Primary School (“the governing body”) have, in accordance with section 4(2) of the Education Act 2002(1) (“the Act”), consulted the local authority and such persons as appear to them to be appropriate, including the parents of registered pupils at the school and the staff working at the school;

It is the opinion of the Welsh Ministers, having regard to the matters set out in section 1(2) of the Act, that the implementation by the governing body of the provisions of this Order may contribute to the raising of educational standards achieved by children in Wales;

The Welsh Ministers in exercise of the powers conferred upon the National Assembly for Wales by section 2(1) of the Act(2), and now vested in them, on the application of the governing body, make the following Order:

Title and commencement

1. The title of this Order is the Welshpool Church in Wales Primary School (Change to School Session Times) Order 2020 and it comes into force on 1 January 2021.

Exemption from the School Session Regulations

2. Regulation 4(2), (3) and (4) of the Changing of School Session Times (Wales) Regulations 2009⁽¹⁾ does not apply to the governing body of Welshpool Church in Wales Primary School⁽²⁾ of Gungrug Road, Welshpool, Powys, SY21 7EJ.

Time period

3. This Order will have effect until 31 August 2021.
