Mae Rhan 2A o Ddeddf Iechyd y Cyhoedd (Rheoli Clefydau) 1984 yn galluogi Gweinidogion Cymru, drwy reoliadau, i wneud darpariaeth at ddiben atal, diogelu rhag, rheoli neu ddarparu ymateb iechyd y cyhoedd i fynychder neu ledaeniad haint neu halogiad yng Nghymru.

Mae'r Rheoliadau hyn wedi eu gwneud mewn ymateb i'r bygythiad difrifol ac uniongyrchol i iechyd y cyhoedd a berir gan fynychder a lledaeniad coronafeirws syndrom anadolol aciwt difrifol 2 (SARS-CoV-2) yng Nghymru. Mae'r Rheoliadau yn gosod gofynion a chyfngiadau ar unigolion, busnesau ac eraill.

Mae'r Rheoliadau hyn yn gwneud diwygiadau i Reoliadau Diogelu Iechyd (Cyfngiadau Coronafeirws) (Rhif 4) (Cymru) 2020 (O.S. 2020/1219 (Cy. 276)) (y "prif Reoliadau") er mwyn—

- (a) ei gwneud yn ofynnol i bob cinema, ffair, parc difyrrwch, parc thema, amgueddfa, oriel ac atyniad ymwelwyr, boed o dan do neu yn yr awyr agored, fod ar gau;
- (b) egluro bod yn rhaid i barciau a chanolfannau trampolin a pharciau a chanolfannau sglefrio o dan do fod ar gau;

The Health Protection (Coronavirus
Restrictions) (No. 4) (Wales)
(Amendment) Regulations 2020

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

Part 2A of the Public Health (Control of Disease) Act 1984 enables the Welsh Ministers, by regulations, to make provision for the purpose of preventing, protecting against, controlling or providing a public health response to the incidence or spread of infection or contamination in Wales.

These Regulations are made in response to the serious and imminent threat to public health which is posed by the incidence and spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in Wales. The Regulations impose requirements and restrictions on individuals, businesses and others.

These Regulations make amendments to the Health Protection (Coronavirus Restrictions) (No. 4) (Wales) Regulations 2020 (S.I. 2020/1219 (W. 276)) (the "principal Regulations") to—

- (a) require all cinemas, funfairs, amusement parks, theme parks, museums, galleries and visitor attractions to be closed, whether indoors or outdoors;
- (b) clarify that trampoline parks and centres and indoor skate parks and centres must be closed;

- (c) (er gwaethaf y gofynion ar fangreodd busnes penodol i fod ar gau) caniatáu i sinemáu a theatrau o sedd cerbyd agor yn ddarostyngedig i'r gofyniad yn y prif Reoliadau fod pob mesur rhesymol yn cael ei gymryd ar fangreodd busnes i leihau'r risg o ddod i gysylltiad â'r coronafeirws.
- (c) (despite the requirements on certain business premises to be closed) allow drive-in cinemas and theatres to open subject to the requirement in the principal Regulations for all reasonable measures to be taken on business premises to minimise the risk of exposure to coronavirus.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ni luniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has not been prepared as to the likely cost and benefit of complying with these Regulations.

Mae'r Rheoliadau hyn wedi eu gwneud mewn ymateb i'r bygythiad difrifol ac uniongyrchol i iechyd y cyhoedd a berir gan fynychder a lledaeniad coronafeirws syndrom anadol aciwt difrifol 2 (SARS-CoV-2) yng Nghymru.

Mae Gweinidogion Cymru yn ystyried bod y cyfngiadau a'r gofynion a osodir gan y Rheoliadau hyn yn gymesur â'r hyn y maent yn ceisio ei gyflawni, sef ymateb iechyd y cyhoedd i'r bygythiad hwnnw.

Yn unol ag adran 45R o'r Ddeddf honno, oherwydd brys, mae Gweinidogion Cymru o'r farn ei bod yn angenrheidiol gwneud yr offeryn hwn heb fod drafat wedi ei osod gerbron Senedd Cymru ac wedi ei gymeradwyo ganddi drwy benderfyniad.

The Health Protection (Coronavirus

Coming into force on 14 December 2020

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 45C(1) and (3)(c), 45F(2) and 45P(2) of the Public Health (Control of Disease) Act 1984(1).

These Regulations are made in response to the serious and imminent threat to public health which is posed by the incidence and spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in Wales.

The Welsh Ministers consider that restrictions and requirements imposed by these Regulations are proportionate to what they seek to achieve, which is a public health response to that threat.

In accordance with section 45R of that Act the Welsh Ministers are of the opinion that, by reason of urgency, it is necessary to make this instrument without a draft having been laid before, and approved by a resolution of, Senedd Cymru.

(1) 1984 c. 22. Sections 45C, 45F and 45P were inserted by section 129 of the Health and Social Care Act 2008 (c. 14). The functions under these sections are conferred on "the appropriate Minister". Under section 45T(6) of the 1984 Act the appropriate Minister, as respects Wales, is the Welsh Ministers.

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Diogelu Iechyd (Cyfngiadau Coronafeirws) (Rhif 4) (Cymru) (Diwygio) 2020.

(2) Daw'r Rheoliadau hyn i rym ar 14 Rhagfyr 2020.

2.—(1) Mae Rheoliadau Diogelu Iechyd (Cyfngiadau Coronafeirws) (Rhif 4) (Cymru) 2020(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 7(2)(c)—

- (a) ym mharagraff (i), ar ôl “ffilm” mewnosoder “mewn cinema o sedd cerbyd”;
- (b) ar ôl y paragraff hwnnw mewnosoder—
 - “(ia) perfformiad mewn theatr o sedd cerbyd;”.

(3) Yn rheoliad 19, hepgorer paragraff (1A).

(4) Yn rheoliad 47, ar ôl paragraff (4) mewnosoder—

“(4A) At ddibenion y Rheoliadau hyn, mae mangre cinema neu theatr yn cinema neu'n theatr o sedd cerbyd—

- (a) os yw'r fangre yn yr awyr agored, a
- (b) o ran personau sy'n mynd i arddangosiad ffilm neu berfformiad yn y fangre—
 - (i) ni chaniateir iddynt ond gwneud hynny mewn cerbyd caeedig, a
 - (ii) ni chaniateir iddynt, i'r graddau y mae'n rhesymol ymarferol, adael y cerbyd tra byddant yn y fangre.”

(5) Yn Atodlen 1—

- (a) ym mharagraff 3, ar ôl “Theatral” mewnosoder “ac eithrio theatrau o sedd cerbyd”;
- (b) ym mharagraff 6, ar ôl “arcedau diddanu” mewnosoder “, parciau a chanolfannau trampolin, parciau a chanolfannau sglefrio o dan do”;
- (c) ym mharagraff 8, ar ôl “Sinemâu” mewnosoder “ac eithrio sinemâu o sedd cerbyd”.

Title and coming into force

1.—(1) The title of these Regulations is the Health Protection (Coronavirus Restrictions) (No. 4) (Wales) (Amendment) Regulations 2020.

(2) These Regulations come into force on 14 December 2020.

Amendment of the Health Protection (Coronavirus Restrictions) (No. 4) (Wales) Regulations 2020

2.—(1) The Health Protection (Coronavirus Restrictions) (No. 4) (Wales) Regulations 2020(1) are amended as follows.

(2) In regulation 7(2)(c)—

- (a) in paragraph (i), after “film” insert “at a drive-in cinema”;
- (b) after that paragraph insert—
 - “(ia) a performance at a drive-in theatre;”.

(3) In regulation 19, omit paragraph (1A).

(4) In regulation 47, after paragraph (4) insert—

“(4A) For the purposes of these Regulations, the premises of a cinema or theatre is a drive-in cinema or theatre if—

- (a) the premises are outdoors, and
- (b) persons attending the showing of a film or performance at the premises—
 - (i) may only do so in an enclosed vehicle, and
 - (ii) may not, in so far as is reasonably practicable, leave the vehicle while at the premises.”

(5) In Schedule 1—

- (a) in paragraph 3, after “Theatres” insert “other than drive-in theatres”;
- (b) in paragraph 6, after “amusement arcades” insert “, trampoline parks and centres, indoor skate parks and centres”;
- (c) in paragraph 8, after “Cinemas” insert “other than drive-in cinemas”.
