*(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)*

Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn pennu uchafsymiau ac isafsymiau'r taliadau colli cartref sy'n daladwy o dan Ddeddf Digollediad Tir 1973 ("y Ddeddf") i'r rhai sy'n meddiannu annedd sydd â buddiant perchennog. Mae'r Rheoliadau hyn yn cynyddu hefyd swm y taliad colli cartref sy'n daladwy o dan y Ddeddf mewn unrhyw achos arall.

Mae hawl gan berson a ddadleolir o annedd drwy brynu gorfodol neu o dan amgylchiadau eraill a bennir yn adran 29 o'r Ddeddf i gael taliad colli cartref.

Mewn achosion pan fo gan berson sy'n meddiannu annedd ar ddyddiad y dadleoli fuddiant perchennog, mae adran 30(1) o'r Ddeddf yn darparu bod swm y taliad colli cartref yn cael ei gyfrifo fel canran o werth y buddiant hwnnw ar y farchnad, a hynny'n ddarostyngedig i uchafswm ac isafswm.

Mae adran 30(2) o'r Ddeddf yn pennu swm y taliad colli cartref sy'n ddyledus mewn unrhyw achos arall.

Mae rheoliad 2(a) o'r Rheoliadau hyn yn cynyddu'r uchafswm sy'n daladwy o dan adran 30(1) o'r Ddeddf o £59,000 i £62,000 ac mae rheoliad 2(b) yn cynyddu'r isafswm o £5,900 i £6,200.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations, which apply in relation to Wales, increase the maximum and minimum amounts of home loss payments payable under the Land Compensation Act 1973 ("the Act") to those occupying a dwelling who have an owner's interest. These Regulations also increase the amount of home loss payment payable under the Act in any other case.

A person who is displaced from a dwelling by compulsory purchase or in other circumstances specified in section 29 of the Act is entitled to a home loss payment.

Section 30(1) of the Act provides that in cases where a person occupying a dwelling on the date of displacement has an owner's interest, the amount of home loss payment is calculated as a percentage of the market value of that interest, subject to a maximum and minimum amount.

Section 30(2) of the Act specifies the amount of the home loss payment due in any other case.

Regulation 2(a) of these Regulations increases the maximum amount payable under section 30(1) of the Act from £59,000 to £62,000 and regulation 2(b) increases the minimum amount from £5,900 to £6,200.

Mae rheoliad 2(c) yn cynyddu'r taliad colli cartref sy'n ddyledus o dan adran 30(2) o'r Ddeddf o £5,900 i £6,200.

Mae'r symiau diwygiedig yn gymwys pan fo'r dadleoli'n digwydd ar 27 Ebrill 2020 neu ar ôl hynny.

Mae rheoliad 3 yn dirymu, gydag arbedion, Reoliadau Taliadau Colli Cartref (Symiau Rhagnodedig) (Cymru) 2018.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

Regulation 2(c) increases the home loss payment due under section 30(2) of the Act from £5,900 to £6,200.

The revised amounts apply where displacement occurs on or after 27 April 2020.

Regulation 3 revokes, with savings, the Home Loss Payments (Prescribed Amounts) (Wales) Regulations 2018.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddir i'r Ysgrifennydd Gwladol gan adran 30(5) o Ddeddf Digollediad Tir 1973(1) ac sy'n arferadwy bellach ganddynt hwy o ran Cymru(2).

The Welsh Ministers make the following Regulations in exercise of the powers conferred upon the Secretary of State by section 30(5) of the Land Compensation Act 1973(1) and now exercisable by them in relation to Wales(2).

**Enwi, cychwyn, cymhwyso a dehongli**

**Title, commencement, application and interpretation**

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Taliadau Colli Cartref (Symiau Rhagnodedig) (Cymru) 2020 a deuant i rym ar 27 Ebrill 2020.

1.—(1) The title of these Regulations is the Home Loss Payments (Prescribed Amounts) (Wales) Regulations 2020 and they come into force on 27 April 2020.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(2) These Regulations apply in relation to Wales.

(3) Yn y Rheoliadau hyn—

Trosglwyddwyd swyddogaethau Cynulliad Cenedlaethol Cymru o dan adran 30 i Weinidogion Cymru yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p. 32).

ystyr “y Ddeddf” (“*the Act*”) yw Deddf Digollediad Tir 1973;

mae i “taliad colli cartref” yr ystyr a roddir i “home loss payment” gan adran 29(1) o’r Ddeddf.

“the Act” (“*y Ddeddf*”) means the Land Compensation Act 1973;

“home loss payment” (“*taliad colli cartref*”) has the meaning given by section 29(1) of the Act.

### Diwygio symiau rhagnodedig y taliad colli cartref

2. Pan fo dyddiad y dadleoli ar 27 Ebrill 2020 neu ar ôl hynny—

- (a) £62,000 yw uchafswm rhagnodedig y taliad colli cartref at ddibenion adran 30(1) o’r Ddeddf,
- (b) £6,200 yw isafswm rhagnodedig y taliad colli cartref at ddibenion adran 30(1) o’r Ddeddf, ac
- (c) £6,200 yw swm rhagnodedig y taliad colli cartref at ddibenion adran 30(2) o’r Ddeddf.

### Dirymu ac arbed

3.—(1) Yn ddarostyngedig i baragraff (2), mae Rheoliadau Taliadau Colli Cartref (Symiau Rhagnodedig) (Cymru) 2018(1) wedi eu dirymu.

(2) Bydd y Rheoliadau y cyfeirir atynt ym mharagraff (1) yn parhau i gael effaith mewn perthynas â dadleoli sy’n digwydd cyn 27 Ebrill 2020.

### Revision of prescribed amounts for home loss payment

2. When the date of displacement is on or after 27 April 2020—

- (a) the prescribed maximum amount of home loss payment for the purposes of section 30(1) of the Act is £62,000,
- (b) the prescribed minimum amount of home loss payment for the purposes of section 30(1) of the Act is £6,200, and
- (c) the prescribed amount of home loss payment for the purposes of section 30(2) of the Act is £6,200.

### Revocation and savings

3.—(1) Subject to paragraph (2), the Home Loss Payments (Prescribed Amounts) (Wales) Regulations 2018(1) are revoked.

(2) The Regulations referred to in paragraph (1) will continue to have effect in relation to a displacement occurring before 27 April 2020.
