**The A465 Trunk Road (Llanfoist
Interchange to Hardwick
Roundabout, Abergavenny,
Monmouthshire) (Temporary
Prohibition of Vehicles & Cyclists)
Order 2020**

Made 15 April 2020

Coming into force 20 April 2020

The Welsh Ministers, as traffic authority for the A465 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A465 Trunk Road (Llanfoist Interchange to Hardwick Roundabout, Abergavenny, Monmouthshire) (Temporary Prohibition of Vehicles & Cyclists) Order 2020 and it comes into force on 20 April 2020.

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the eastbound carriageway of the A465 Neath to Abergavenny Trunk Road that extends from the nosing of the eastbound exit slip road at Llanfoist Interchange to its junction with the circulatory carriageway of Hardwick Roundabout, Abergavenny, Monmouthshire;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 20:00 hours on 20 April 2020 and ending when the temporary traffic signs are permanently removed.

Prohibitions

3. No person may, during the works period, drive any vehicle on the length of the trunk road specified in article 2 of this Order.

4. No person may, during the works period, ride any pedal cycle on the length of the trunk road specified in article 2 of this Order.

Application

5. The prohibitions in articles 3 and 4 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

6. The maximum duration of this Order is 18 months.
