## The Health Protection (Coronavirus, Public Health Information for Persons Travelling to Wales etc.) Regulations 2020

### PART 3

#### Offences, penalties and prosecutions

##### Offences

6.—(1) A person who contravenes a requirement in regulation 3(1) <sup>F1</sup>... <sup>F2</sup>... or regulation 4 commits an offence.

(2) It is a defence to a charge of committing the offence of contravening the requirement in [<sup>F3</sup>[<sup>F4</sup> regulation 3(1) <sup>F5</sup>... <sup>F6</sup>...] or] regulation 4 to show that the person had a reasonable excuse for the contravention.

(3) A person who commits an offence under paragraph (1) is liable on summary conviction to a fine.
