# PART 3

Offences, penalties and prosecutions

### Offences

**6.**—(1) A person who contravenes a requirement in regulation  $3(1)^{F1}$ ...  $F^{2}$ ... or regulation 4 commits an offence.

(2) It is a defence to a charge of committing the offence of contravening the requirement in  $[^{F3}[^{F4}$ regulation 3(1)  $^{F5}$ ...  $^{F6}$ ...] or] regulation 4 to show that the person had a reasonable excuse for the contravention.

(3) A person who commits an offence under paragraph (1) is liable on summary conviction to a fine.
