Gwneir y Rheoliadau hyn drwy arfer y pwerau a roddwyd gan baragraff 11A(1) o Atodlen 2 i Reoliadau'r Fasnach mewn Anifeiliaid a Chynhyrchion Perthynol (Cymru) 2011 (O.S. 2011/2379) (Cy. 252).

Mae Rheoliad 2 yn diwygio Erthygl 1 o Benderfyniad y Comisiwn 2000/572/EC dyddiedig 8 Medi 2000 sy'n gosod yr amodau iechyd anifeiliaid a'r cyhoedd ac ardystio milfeddygol ar gyfer mewnforio paratoadau cig i'r Gymuned o drydydd gwledydd er mwyn egluro bod y Penderfyniad hwn yn gymwys i fewnforion i Gymru o drydydd gwledydd fel y'u diffinnir yn Erthygl 1(2) o'r Penderfyniad hwnnw.

Mae Rheoliad 3 yn atal dros dro y gofyniad i baratoadau cig a fewnforir i Gymru o sefydliadau a leolir yn Aelod-wladwriaethau'r AEE, Ynysoedd Ffaröe, Kalaallit Nunaat (Greenland) neu'r Swistir fod wedi'u rhewi'n ddwfn.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations are made in exercise of the powers conferred by paragraph 11A(1) of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011 (S.I. 2011/2379) (W. 252).

Regulation 2 amends Article 1 of Commission Decision 2000/572/EC of 8 September 2000 laying down the animal and public health and veterinary certification conditions for imports of meat preparations into the Community from third countries in order to clarify that this Decision applies to imports into Wales from third countries as defined in Article 1(2) of that Decision.

Regulation 3 temporarily suspends the requirement for meat preparations imported into Wales from establishments situated in EEA member States, the Faroe Islands, Greenland or Switzerland to be deep frozen.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers conferred by paragraph 11A(1) of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011(1), make the following Regulations.

**Title, application and commencement**

1.—(1) The title of these Regulations is the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) Regulations 2021.

(2) These Regulations apply in relation to Wales and come into force on 6 January 2021.

**Amendment to Commission Decision 2000/572/EC**

2. In Article 1(1) of Commission Decision 2000/572/EC of 8 September 2000 laying down the animal and public health and veterinary certification conditions for imports of meat preparations into the

### **Addasiadau darfordol i Benderfyniad y Comisiwn 2000/572/EC**

3.—(1) Mae paragraph (2) o'r rheoliad hwn yn cael effaith yn ystod y cyfnod sy'n cychwyn ar y diwrnod y daw'r Rheoliadau hyn i rym ac sy'n gorffen am hanner nos ar 31 Mawrth 2021.

(2) Mae Erthygl 3 o Benderfyniad y Comisiwn yn gymwys fel pe bai—

- (a) "other than in relation to imports of meat preparations originating from, or produced in, an establishment situated in a territory subject to special transitional import arrangements," wedi'i fewnosod, ym mharagraff 3, cyn "they";
- (b) "4. In this Article, "territory subject to special transitional import arrangements" has the same meaning as in point (a) of the definition of "territory subject to special transitional import arrangements" in paragraph 2 of Annex 6 to Regulation (EU) 2017/625 of the European Parliament and of the Council on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products(2)." wedi'i fewnosod ar y diwedd.

Community from third countries(1) ('the Commission Decision'), after "meat preparations" insert "from third countries".

### **Transitory modification of Commission Decision 2000/572/EC**

3.—(1) Paragraph (2) of this regulation has effect during the period beginning with the day on which these Regulations come into force and ending at midnight on 31 March 2021.

(2) Article 3 of the Commission Decision applies as if—

- (a) in paragraph 3, before "they", there were inserted "other than in relation to imports of meat preparations originating from, or produced in, an establishment situated in a territory subject to special transitional import arrangements,";
- (b) at the end, there were inserted—

"4. In this Article, "territory subject to special transitional import arrangements" has the same meaning as in point (a) of the definition of "territory subject to special transitional import arrangements" in paragraph 2 of Annex 6 to Regulation (EU) 2017/625 of the European Parliament and of the Council on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products(2)."
