Mae Mesur Plant a Theuluoedd (Cymru) 2010 (“y Mesur”) yn ei gwneud yn ofynnol i awdurdodau Cymreig wneud a dangos eu cyfraniad tuag at ddileu tldi plant yng Nghymru.

The Children and Families (Wales) Measure 2010 (“the Measure”) requires Welsh authorities to make and demonstrate their contribution towards the eradication of child poverty in Wales.

Mae'r Rheoliadau hyn yn ychwanegu cyd-bwyllgorau corfforedig a sefydlir drwy reoliadau a wneir o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (“Deddf 2021”) at y rhestr o awdurdodau Cymreig sy'n ddarostyngedig i'r ddyletswydd i lunio a chyhoeddi strategaeth ar gyfer cyfrannu at ddileu tldi plant yng Nghymru ac y mae'n rhaid iddynt roi sylw i ganllawiau neu gyfarwyddiadau a roddir o dan y Mesur gan Weinidogion Cymru.

These Regulations add corporate joint committees established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021 (“the 2021 Act”) to the list of Welsh authorities subject to the duty to prepare and publish a strategy for contributing to the eradication of child poverty in Wales and who have to have regard to guidance or directions given under the Measure by Welsh Ministers.

Mae'r Rheoliadau hyn yn gysylltiedig â rheoliadau a sefydlodd gyd-bwyllgorau corfforedig penodol o dan Ran 5 o Ddeddf 2021.

These Regulations are connected with regulations which established certain corporate joint committees under Part 5 of the 2021 Act.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r rheoliadau a sefydlodd gyd-bwyllgorau corfforedig a rheoliadau cysylltiedig. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol. Gellir cael copi oddi wrth: Yr Is-adran Cyllid Strategol Llywodraeth Leol, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to the regulations which established corporate joint committees and connected regulations. **Title and coming into force**

1.—(1) The title of these Regulations is the Children and Families (Wales) Measure 2010 (Amendment to the List of Welsh Authorities) Regulations 2021.
