**ROAD TRAFFIC, WALES**

**The A5 Trunk Road (Glyndyfrdwy,  
Denbighshire) (30 mph Speed  
Limit) Order 2021**

*Made* 8 June 2021

*Coming into force* 11 June 2021

The Welsh Ministers, as traffic authority for the relevant length of the A5 trunk road, in exercise of the powers conferred upon them by section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984<sup>(1)</sup>, make this Order.

The Welsh Ministers have consulted with the Chief Officer of North Wales Police and given public notice of their intention to make this Order in accordance with regulations 5(1) and 6(1) of the Secretary of State’s Traffic Orders (Procedure) (England and Wales) Regulations 1990<sup>(2)</sup>.

**Title and commencement**

1. The title of this Order is the A5 Trunk Road (Glyndyfrdwy, Denbighshire) (30 mph Speed Limit) Order 2021 and this Order comes into force on 11 June 2021.

**Interpretation**

2. In this Order—

“exempted vehicle” (*“cerbyd esempt”*) means:

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1);
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
  - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
  - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A5 London to Holyhead trunk road.

### **Restriction**

3. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 30 miles per hour on the length of the trunk road at Glyndyfrdwy, Denbighshire that extends from a point 146 metres west to a point 427 metres west of the centre-point of its junction with the unclassified road signed to Rhewl and the length of the trunk road that extends from a point 390 metres east to a point 700 metres east of the centre-point of that junction.
