Mae'r Rheoliadau hyn wedi eu gwneud drwy arfer y pwerau a roddir gan baragraff 7 o Atodlen 4 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (p. 16) ac maent yn diwygio Rheoliadau Iechyd Planhigion (Ffioedd) (Coedwigaeth) (Cymru) 2019 (O.S. 2019/497 (Cy. 114)).

Mae'r Rheoliadau hyn yn darparu ar gyfer cynyddu'r ffioedd am wasanaethau mewn perthynas ag awdurdodiadau pasbortau planhigion a cheisiadau am dystysgrifau ffytoiechydol (gan gynnwys dystysgrifau ffytoiechydol ar gyfer ailallforio) i adlewyrchu cynnydd chwyddiannol o ran y gost o ddarparu'r gwasanaethau hynny ers cyflwyno'r ffioedd hynny. Mae'r ffioedd sy'n ymwneud ag awdurdodiadau pasbortau planhigion wedi cynyddu 34% ar gyfer y cyfnod rhwng 2006 a 2020, tra bod y ffioedd ar gyfer dystysgrifau allforio wedi cynyddu 40% ar gyfer y cyfnod rhwng 2004 a 2020 (yn seiliedig ar y Mynegai Prisiau Defnyddwyr gan gynnwys costau tai perchen-feddianwyr (CPIH)).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenreheidol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made in exercise of the powers conferred by paragraph 7 of Schedule 4 to the European Union (Withdrawal) Act 2018 (c. 16) and amend the Plant Health (Fees) (Forestry) (Wales) Regulations 2019 (S.I. 2019/497 (W. 114)).

These Regulations provide for increases in the fees for services in relation to plant passport authorities and applications for phytosanitary certificates (including phytosanitary certificates for re-export) to reflect an inflationary rise in the cost of providing those services since the introduction of those fees. The fees relating to plant passport authorities have increased by 34% for the period between 2006 and 2020, while fees for export certification have increased by 40% for the period between 2004 and 2020 (based on the Consumer Price Index including owner occupiers' housing costs (CPIH)).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Plant Health (Fees) (Forestry) (Wales) (Amendment) (No. 2) Regulations 2021

The Welsh Ministers make these Regulations in exercise of the powers conferred by paragraph 7 of Schedule 4 to the European Union (Withdrawal) Act 2018(1).

Title and commencement

1.—(1) The title of these Regulations is the Plant Health (Fees) (Forestry) (Wales) (Amendment) (No. 2) Regulations 2021.

(2) These Regulations come into force on 5 August 2021.

The meaning of “appropriate authority” in paragraph 8 of Schedule 4 to the 2018 Act was amended by section 41(4) of, and paragraph 47(5) of Schedule 5 to, the European Union (Withdrawal Agreement) Act 2020 (c. 1).

2.—(1) The Plant Health (Fees) (Forestry) (Wales) Regulations 2019(1) are amended as follows.

(2) For Schedule 1 substitute—
