Mae rheoliad 2 yn diwygio'r dyddiad yn rheoliad 3(1) o Reoliadau Paratoadau Cig (Diwygio ac Addasiadau Darfodol) (Cymru) (Ymadael â'r UE) 2021 (O.S. 2021/1 (Cy. 1)) er mwyn estyn effaith y Rheoliadau hynny, sydd, mewn perthynas â mewnfiorion sy'n tarddu o sefydliadau a leolir yn Aelod-wladwriaethau'r AEE, Ynyssoedd Ffaro, yr Ynys Las neu'r Swistir, neu a gynhyrchir ynddynt, yn atal dros dro y gofyniad i baratoadau cig a fewnfori i Gymru fod wedi eu rhewi'n ddwfn. Gosodir y gofyniad hwnnw gan Erthygl 3(3) o Benderfyniad y Comisiwn 2000/572/EC dyddiedig 8 Medi 2000 sy'n gosod yr amodau iechyd anifeiliaid a'r cyhoedd ac ardystio milfeddygol ar gyfer mewnfiorio paratoadau cig i'r Gymuned o drydydd gwledydd (EUDN 2000/572). Estynnir yr ataliad hyd hanner nos ar 31 Rhagfyr 2021. Cafodd y dyddiad ei ddiwygio yn flaenorol gan Reoliadau Paratoadau Cig (Diwygio ac Addasiadau Darfodol) (Cymru) (Ymadael â'r UE) (Diwygio) 2021 (O.S. 2021/376 (Cy. 117)).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made in exercise of the powers conferred by paragraph 11A(1) of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011 (S.I. 2011/2379 (W. 252)).

Regulation 2 amends the date in regulation 3(1) of the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) Regulations 2021 (S.I. 2021/1 (W. 1)) in order to extend the effect of those Regulations, which, in relation to imports originating from or produced in, establishments situated in EEA member States, the Faroe Islands, Greenland or Switzerland, temporarily suspend the requirement for meat preparations imported into Wales to be deep frozen. That requirement is imposed by Article 3(3) of Commission Decision 2000/572/EC of 8 September 2000 laying down the animal and public health and veterinary certification conditions for imports of meat preparations into the Community from third countries (EUDN 2000/572). The extension of the suspension is until midnight on 31 December 2021. The date had previously been amended by the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) (Amendment) Regulations 2021 (S.I. 2021/376 (W. 117)).

The Welsh Ministers, in exercise of the powers conferred by paragraph 11A(1) of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011(1), make the following Regulations.

Title and commencement

1.—(1) The title of these Regulations is the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) (Amendment) (No. 2) Regulations 2021.

(2) These Regulations come into force on 29 September 2021.
