Mae'r Rheoliadau hyn yn diwygio Rheoliadau Rheolaethau Swyddogol (Estyn Cyfnodau Trosiannol) 2021 a Rheoliadau Paratoadau Cig (Diwygio ac Addasiadau Darfodol) (Cymru) (Ymadael â'r UE) 2021.

Mae rheoliad 2 yn diwygio Rheoliadau Rheolaethau Swyddogol (Estyn Cyfnodau Trosiannol) 2021 er mwyn estyn, o ran Cymru, ddyddiad dod i ben y cyfnod graddoli trosiannol ("*transitional staging period*") o 31 Rhagfyr 2022 i 31 Ionawr 2024.

Mae rheoliad 3 yn diwygio Rheoliadau Paratoadau Cig (Diwygio ac Addasiadau Darfodol) (Cymru) (Ymadael â'r UE) 2021 er mwyn estyn yr ataliad dros dro ar y gofyniad i baratoadau cig fod wedi eu rhewi'n ddwfn pan fônt yn cael eu mewnfario i Gymru o Aelod-wladwriaethau'r AEE, Ynysoedd Ffaro, yr Ynys Las neu'r Swistir, gan gysoni â'r dyddiad a benodwyd fel dyddiad dod i ben estynedig y cyfnod graddoli trosiannol (rheoliad 2).

Ystyriwyd cod ymarfer Gweinidogion Cymru ar gynnal asesiadau effaith rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Official Controls (Extension of Transitional Periods) Regulations 2021 and the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) Regulations 2021.

Regulation 2 amends the Official Controls (Extension of Transitional Periods) Regulations 2021 to extend, in relation to Wales, the end date of the "transitional staging period" from 31 December 2022 to 31 January 2024.

Regulation 3 amends the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) Regulations 2021 to extend the temporary suspension of the requirement for meat preparations to be deep frozen where they are imported into Wales from EEA member States, the Faroe Islands, Greenland or Switzerland, bringing it into line with the date appointed as the extended end date of the "transitional staging period" (regulation 2).

The Welsh Ministers' code of practice on the carrying out of regulatory impact assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers make the following Regulations in exercise of the powers conferred by—

- (a) paragraff 2 o Atodiad 6 i Reoliad (EU) 2017/625 Senedd Ewrop a'r Cyngor ar reolaethau swyddogol a gweithgareddau swyddogol eraill a gyflawnir i sicrhau y cymhwysir y gyfraith o ran bwyd a bwyd anifeiliaid, rheolau ynghylch iechyd a lles anifeiliaid, iechyd planhigion a chynhyrchion diogelu planhigion(1); a
- (b) paragraff 11A(1) o Atodlen 2 i Reoliadau'r Fasnach mewn Anifeiliaid a Chynhyrchion Perthynol (Cymru) 2011(2).

- (a) paragraph 2 of Annex 6 to Regulation (EU) 2017/625 of the European Parliament and of the Council on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products(1); and
- (b) paragraph 11A(1) of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011(2).

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Rheolaethau Swyddogol (Estyn Cyfnodau Trosiannol) (Diwygio) (Cymru) 2022.

- (a) yn rhychwantu Cymru a Lloegr;
- (b) yn gymwys o ran Cymru;
- (c) yn dod i rym ar 30 Rhagfyr 2022.

2.—(1) Mae Rheoliadau Rheolaethau Swyddogol (Estyn Cyfnodau Trosiannol) 2021(1) wedi eu diwygio fel a ganlyn.

2. In relation to Wales, for the purposes of sub-paragraph (b) of the definition of “the transitional staging period” in paragraph 2 (interpretation) of Annex 6 to Regulation (EU) 2017/625 of the European Parliament and of the Council on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products, the appointed date is 31 January 2024.

In accordance with Article 144(7) of Regulation (EU) 2017/625 of the European Parliament and of the Council on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products, the Welsh Ministers, before making these Regulations, have consulted such bodies and persons as appear to the Welsh Ministers to be representative of the interests likely to be substantially affected by these Regulations and such other bodies or persons as the Welsh Ministers consider appropriate.

Title, extent, application and commencement

1.—(1) The title of these Regulations is the Official Controls (Extension of Transitional Periods) (Amendment) (Wales) Regulations 2022.

(2) These Regulations—

- (a) extend to England and Wales;
- (b) apply in relation to Wales;
- (c) come into force on 30 December 2022.

Amendment to the Official Controls (Extension of Transitional Periods) Regulations 2021

2.—(1) The Official Controls (Extension of Transitional Periods) Regulations 2021(1) are amended as follows.

(2) For regulation 2 (end of the transitional staging period) substitute—

“End of the transitional staging period

2. In relation to Wales, for the purposes of sub-paragraph (b) of the definition of “the transitional staging period” in paragraph 2 (interpretation) of Annex 6 to Regulation (EU) 2017/625 of the European Parliament and of the Council on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products, the appointed date is 31 January 2024.
”.
