Mae'r Rheoliadau hyn yn diwygio, o ran Cymru, Reoliad Gweithredu'r Comisiwn (EU) 2019/1793 ar gynyddu dros dro reolaethau swyddogol a mesurau brys sy'n rheoli mynediad i'r Undeb i nwyddau penodol o drydydd gwledydd penodol ("Rheoliad 2019/1793").

These Regulations amend, in relation to Wales, Commission Implementing Regulation (EU) 2019/1793 on the temporary increase of official controls and emergency measures governing the entry into the Union of certain goods from certain third countries ("Regulation 2019/1793").

Mae rheoliad 2 yn amnewid, gyda diwygiadau, Atodiadau 1, 2 a 2a i Reoliad 2019/1793. Amnewidir Atodiad 1 drwy ddefnyddio pwerau yn Erthyglau 47(2)(b) a 54(4)(a) o Reoliad (EU) 2017/625 ar reolaethau swyddogol a gweithgareddau swyddogol eraill a gyflawnir i sicrhau y cymhwysir y gyfraith o ran bwyd a bwyd anifeiliaid, rheolau ynghylch iechyd a lles anifeiliaid, iechyd planhigion a chynhyrchion diogelu planhigion. Amnewidir Atodiadau 2 a 2a drwy ddefnyddio pwerau yn Erthygl 53 o Reoliad (EC) Rhif 178/2002 sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd ac Erthygl 54(4)(b) o Reoliad (EU) 2017/625.

Regulation 2 substitutes, with amendments, Annexes 1, 2 and 2a to Regulation 2019/1793. The substitution of Annex 1 is made using powers in Articles 47(2)(b) and 54(4)(a) of Regulation (EU) 2017/625 on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products. The substitution of Annexes 2 and 2a is made using powers in Article 53 of Regulation (EC) No 178/2002 laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety and Article 54(4)(b) of Regulation (EU) 2017/625.

Mae Atodiad 1 yn cynnwys y rhestr o fwyd a bwyd anifeiliaid nad ydynt yn dod o anifeiliaid sy'n ddarostyngedig i gynnydd dros dro mewn rheolaethau swyddogol mewn safleoedd rheoli ar y ffin neu mewn safleoedd rheoli ym Mhrydain Fawr. Mae'r newidiadau a wneir i Atodiad 1 fel a ganlyn.

- Mae amlder y gwiriadau ar bupur du o Frasil (ar gyfer Salmonella) wedi ei gynyddu o 20% i 50%.
- Mae'r cofnod ar gyfer cnau daear (pysgnau) a chynhyrchion cysylltiedig o Frasil (ar gyfer aflatoxinau) wedi ei drosglwyddo i Atodiad 1 (o Atodiad 2, Tabl 1). Nid oes unrhyw newid i amlder rhagnodedig y gwiriadau, sy'n parhau ar 10%.
- Cofnod newydd ar gyfer cnau daear (pysgnau) a chynhyrchion cysylltiedig o Frasil (ar gyfer gweddillion pleiddiaid). Mae amlder y gwiriadau wedi ei ragnodi ar 20%.
- Mae'r cofnod ar gyfer aeron goji o Tsieina (ar gyfer gweddillion pleiddiaid) wedi ei ddileu.
- Mae'r cofnod ar gyfer cnau daear (pysgnau) a chynhyrchion cysylltiedig o Tsieina (ar gyfer aflatoxinau) wedi ei drosglwyddo i Atodiad 1 (o Atodiad 2, Tabl 1). Mae amlder y gwiriadau wedi ei leihau o 20% i 10%.
- Mae'r cofnod ar gyfer hadau sesamwm o Ethiopia (ar gyfer Salmonella) wedi ei ddileu (mae'r cofnod wedi ei drosglwyddo i Atodiad 2, Tabl 1).
- Mae amlder y gwiriadau ar gnau cyll a chynhyrchion cysylltiedig o Georgia (ar gyfer aflatoxinau) wedi ei leihau o 50% i 20%.
- Mae amlder y gwiriadau ar ocr o India (ar gyfer gweddillion pleiddiaid) wedi ei gynyddu o 10% i 20%.
- Mae'r cofnod ar gyfer pupurau o rywogaethau'r *Capsicum* (pupurau melys neu bupurau heblaw pupurau melys) o Sri Lanka (ar gyfer aflatoxinau) wedi ei ddileu (mae'r cofnod wedi ei drosglwyddo i Atodiad 2, Tabl 1).
- Mae amlder y gwiriadau ar jacffrwyth o Falaysia (ar gyfer gweddillion pleiddiaid) wedi ei gynyddu o 20% i 50%.
- Cofnod newydd ar gyfer bwyd sy'n cynnwys, neu fwyd sydd ar ffurf, dail betel (*Piper betle*) o Wlad Thai (ar gyfer Salmonella). Mae amlder y gwiriadau wedi ei ragnodi ar 10%.

Annex 1 contains the list of food and feed of non-animal origin that is subject to a temporary increase in official controls at border control posts or at control points in Great Britain. The changes being made to Annex 1 are as follows.

- The frequency of checks on black pepper from Brazil (for Salmonella) is increased from 20% to 50%.
- The entry for groundnuts (peanuts) and associated products from Brazil (for aflatoxins) is transferred into Annex 1 (from Annex 2, Table 1). There is no change to the prescribed frequency of checks, which remains at 10%.
- A new entry for groundnuts (peanuts) and associated products from Brazil (for pesticide residues). The frequency of checks is prescribed at 20%.
- The entry for goji berries from China (for pesticide residue) has been removed.
- The entry for groundnuts (peanuts) and associated products from China (for aflatoxins) is transferred into Annex 1 (from Annex 2, Table 1). The frequency of checks is decreased from 20% to 10%.
- The entry for sesamum seeds from Ethiopia (for Salmonella) has been removed (the entry is transferred into Annex 2, Table 1).
- The frequency of checks on hazelnuts and associated products from Georgia (for aflatoxins) is decreased from 50% to 20%.
- The frequency of checks on okra from India (for pesticide residues) is increased from 10% to 20%.
- The entry for peppers of the *Capsicum* species (sweet or other than sweet) from Sri Lanka (for aflatoxins) has been removed (the entry is transferred into Annex 2, Table 1).
- The frequency of checks on jackfruit from Malaysia (for pesticide residues) is increased from 20% to 50%.
- A new entry for food containing or consisting of betel leaves (*Piper betle*) from Thailand (for Salmonella). The frequency of checks is prescribed at 10%.

- Mae amlder y gwiriadau ar bupurau o rywogaethau'r *Capsicum* (ac eithrio pupurau melys) o Wlad Thai (ar gyfer gweddillion pleiddiaid) wedi ei gynyddu o 10% i 20%.
- Mae'r cofnod ar gyfer grawnwin sych (gan gynnwys grawnwin sych sydd wedi eu torri neu eu crawennu i ffurfio past heb driniaeth bellach) o Dwrci (ar gyfer Ocratocsin A) wedi ei ddileu.
- Mae'r cofnod ar gyfer cnau cyll a chynhyrchion cysylltiedig o Dwrci (ar gyfer aflatocsinau) wedi ei drosglwyddo i Atodiad 1 (o Atodiad 2, Tabl 1). Nid oes unrhyw newid i amlder rhagnodedig y gwiriadau, sy'n parhau ar 5%.
- Cofnod newydd ar gyfer lemonau o Dwrci (ar gyfer gweddillion pleiddiaid). Mae amlder y gwiriadau wedi ei ragnodi ar 20%.
- Mae amlder y gwiriadau ar gyfer mandarins (gan gynnwys tanjerins a satswmas), clementinau, wilkings a hybridiau sitrws tebyg o Dwrci (ar gyfer gweddillion pleiddiaid) wedi ei gynyddu o 5% i 20%.
- Mae amlder y gwiriadau ar orenau o Dwrci (ar gyfer gweddillion pleiddiaid) wedi ei gynyddu o 10% i 20%.
- Mae amlder y gwiriadau ar bupurau melys (*Capsicum annum*) o Dwrci (ar gyfer gweddillion pleiddiaid) wedi ei gynyddu o 10% i 20%.
- Cofnod newydd ar gyfer pupurau o rywogaethau'r *Capsicum* (ac eithrio pupurau melys) o Dwrci (ar gyfer gweddillion pleiddiaid). Mae amlder y gwiriadau wedi ei ragnodi ar 20%.
- Mae amlder y gwiriadau ar bupurau o rywogaethau'r *Capsicum* (ac eithrio pupurau melys) o Uganda (ar gyfer gweddillion pleiddiaid) wedi ei gynyddu o 20% i 50%.
- Mae'r cofnod ar gyfer cnau pistasio a chynhyrchion cysylltiedig o'r Unol Daleithiau (ar gyfer aflatocsinau) wedi ei ddileu.
- The frequency of checks on peppers of the *Capsicum* species (other than sweet) from Thailand (for pesticide residues) is increased from 10% to 20%.
- The entry for dried grapes (including dried grapes cut or crusted into a paste without further treatment) from Turkey (for Ochratoxin A) has been removed.
- The entry for hazelnuts and associated products from Turkey (for aflatoxins) is transferred into Annex 1 (from Annex 2, Table 1). There is no change to the prescribed frequency of checks, which remains at 5%.
- A new entry for lemons from Turkey (for pesticide residues). The frequency of checks is prescribed at 20%.
- The frequency of checks for mandarins (including tangerines and satsumas), clementine, wilkings and similar citrus hybrids from Turkey (for pesticide residues) is increased from 5% to 20%.
- The frequency of checks on oranges from Turkey (for pesticide residues) is increased from 10% to 20%.
- The frequency of checks on sweet peppers (*Capsicum annum*) from Turkey (for pesticide residues) is increased from 10% to 20%.
- A new entry for peppers of the *Capsicum* species (other than sweet) from Turkey (for pesticide residues). The frequency of checks is prescribed at 20%.
- The frequency of checks on peppers of the *Capsicum* species (other than sweet) from Uganda (for pesticide residues) is increased from 20% to 50%.
- The entry for pistachios and associated products from the United States (for aflatoxins) has been removed.

Mae Atodiad 2, Tabl 1, yn cynnwys y rhestr o fwyd a bwyd anifeiliaid nad ydynt yn dod o anifeiliaid y mae amodau arbennig wedi eu rhagnodi ar eu cyfer sy'n rheoli eu mynediad i Brydain Fawr. Mae'r newidiadau a wneir i Atodiad 2, Tabl 1, fel a ganlyn.

- Cofnod newydd ar gyfer bwyd sy'n cynnwys, neu fwyd sydd ar ffurf, dail betel (*Piper betle*) o Fagladesh (ar gyfer Salmonella). Mae amlder y gwiriadau wedi ei ragnodi ar 50%.
- A new entry for food containing or consisting of betel leaves (*Piper betle*) from Bangladesh (for Salmonella). The frequency of checks is prescribed at 50%.

Annex 2, Table 1, contains the list of food and feed of non-animal origin for which special conditions are prescribed governing their entry into Great Britain. The changes being made to Annex 2, Table 1, are as follows.

 - Mae'r is-raniad TARIC wedi ei ddileu.
- Mae amllder y gwiriadau ar gnau daear (pysgnau) a chynhyrchion cysylltiedig o India (ar gyfer aflatocsinau) wedi ei gynyddu o 10% i 50%.
- Mae'r is-raniad TARIC ar gyfer gwm guar o India wedi ei ddileu.
- Mae'r cofnod ar gyfer pupurau o rywogaethau'r *Capsicum* (pupurau melys neu bupurau heblaw pupurau melys) o Sri Lanka (ar gyfer aflatocsinau) wedi ei drosglwyddo i Atodiad 2, Tabl 1 (o Atodiad 1). Nid oes unrhyw newid i amllder rhagnodedig y gwiriadau, sy'n parhau ar 50%.
- Mae amllder y gwiriadau ar gyfer hadau sesamwm o Sudan (ar gyfer Salmonella) wedi ei gynyddu o 20% i 50%.
- Mae'r cofnod ar gyfer cnau cyll a chynhyrchion cysylltiedig o Dwrci (ar gyfer aflatocsinau) wedi ei ddileu (mae'r cofnod wedi ei drosglwyddo i Atodiad 1).
- Mae amllder y gwiriadau ar ddail gwinwydd o Dwrci (ar gyfer gweddillion plaleiddiaid) wedi ei gynyddu o 20% i 50%.
- The entry for groundnuts (peanuts) and associated products from Brazil (for aflatoxins) has been removed (the entry is transferred into Annex 1).
- The entry for groundnuts (peanuts) and associated products from China (for aflatoxins) has been removed (the entry is transferred into Annex 1).
- The entry for sesamum seeds from Ethiopia (for Salmonella) is transferred into Annex 2, Table 1 (from Annex 1). There is no change to the prescribed frequency of checks, which remains at 50%.
- The entry for betel leaves (*Piper betle*) from India has been amended as follows.
 - The scope of the entry is extended to include food containing betel leaves.
 - The TARIC sub-division has been removed.
- The frequency of checks on groundnuts (peanuts) and associated products from India (for aflatoxins) is increased from 10% to 50%.
- The TARIC sub-division for guar gum from India has been removed.
- The entry for peppers of the *Capsicum* species (sweet or other than sweet) from Sri Lanka (for aflatoxins) is transferred into Annex 2, Table 1 (from Annex 1). There is no change to the prescribed frequency of checks, which remains at 50%.
- The frequency of checks for sesamum seeds from Sudan (for Salmonella) is increased from 20% to 50%.
- The entry for hazelnuts and associated products from Turkey (for aflatoxins) has been removed (the entry is transferred into Annex 1).
- The frequency of checks on vine leaves from Turkey (for pesticide residues) is increased from 20% to 50%.

Mae Atodiad 2, Tabl 2, yn cynnwys rhestr o fwyd cyfansawdd sy'n cynnwys unrhyw fwyd a restrir yn Nhabl 1 yn Atodiad 2 oherwydd y risg o halogi gan aflatocsinau mewn swm sy'n fwy nag 20% o naill ai cynnyrch unigol neu swm y cynhyrchion hynny. Y newid a wneir i Dabl 2 yn Atodiad 2 yw ychwanegu cofnod newydd ar gyfer cymysgeddau o sbeisys.

Mae Atodiad 2a yn cynnwys y rhestr o fwyd a bwyd anifeiliaid nad ydynt yn dod o anifeiliaid sydd wedi eu gwahardd rhag dod i Brydain Fawr. Mae'r cofnod yn Atodiad 2a ar gyfer bwyd sy'n cynnwys, neu fwyd

Annex 2, Table 2, contains a list of compound food containing any of the food listed in Table 1 to Annex 2 due to the risk of contamination by aflatoxins in a quantity above 20% of either a single product or as the sum of those products. The change being made to Table 2 of Annex 2 is to add a new entry for mixtures of spices.

Annex 2a contains the list of food and feed of non-animal origin that is prohibited from entering Great Britain. The entry in Annex 2a for food containing or consisting of betel leaves (*Piper betle*) from

1.—(1) The title of these Regulations is the Official Controls (Import of High-Risk Food and Feed of Non-Animal Origin) (Amendment of Commission Implementing Regulation (EU) 2019/1793) (Wales) Regulations 2022.

(2) These Regulations—

- (a) extend to England and Wales;
- (b) apply in relation to Wales;
- (c) come into force on 17 January 2023.

Amendment of Commission Implementing Regulation (EU) 2019/1793

2.—(1) Commission Implementing Regulation (EU) 2019/1793 on the temporary increase of official controls and emergency measures governing the entry into the Union of certain goods from certain third countries⁽¹⁾ is amended as follows.

(2) For Annex 1, substitute the Annex 1 contained in Schedule 1 to these Regulations.

(3) For Annex 2, substitute the Annex 2 contained in Schedule 2 to these Regulations.

(4) For Annex 2a, substitute the Annex 2a contained in Schedule 3 to these Regulations.

The analytical report must indicate: (a) the results of sampling and analysis for the presence of PCP, performed by the competent authorities of the country of origin or of the country where the consignment is consigned from if that country is different from the country of origin; (b) the measurement uncertainty of the analytical result; (c) the limit of detection (LOD) of the analytical method; (d) the limit of quantification (LOQ) of the analytical method. The extraction before analysis must be performed with an acidified solvent.

The analysis must be carried out according to the modified version of the QuEChERS method or according to an equally reliable method. The modified version of the QuEChERS method is set out in the document “Analytical Quality Control and Method Validation Procedures for Pesticide Residues Analysis in Food and Feed” (SANTE 2017/11813), implemented on 1 January 2020 and available at https://www.eurl-pesticides.eu/userfiles/file/EurlALL/AqcGuidance_SANTE_2019_12682.pdf.

The analytical report must indicate: (a) the results of sampling and analysis for the presence of PCP, performed by the competent authorities of the country of origin or of the country where the consignment is consigned from if that country is different from the country of origin; (b) the measurement uncertainty of the analytical result; (c) the limit of detection (LOD) of the analytical method; (d) the limit of quantification (LOQ) of the analytical method. The extraction before analysis must be performed with an acidified solvent.

The analysis must be carried out according to the modified version of the QuEChERS method or according to an equally reliable method. The modified version of the QuEChERS method is set out in the document “Analytical Quality Control and Method Validation Procedures for Pesticide Residues Analysis in Food and Feed” (SANTE 2017/11813), implemented on 1 January 2020 and available at https://www.eurl-pesticides.eu/userfiles/file/EurlALL/AqcGuidance_SANTE_2019_12682.pdf.
