EXPLANATORY NOTE

Mae Deddf Cwricwlwm ac Asesu (Cymru) 2021 (“Deddf 2021”) yn sefydlu fframwaith cyfreithiol newydd ar gyfer cwricwlwm ac yn gwneud darpariaeth ynghylch asesu ar gyfer disgyblion a phlant yng Nghymru (“y Cwricwlwm i Gymru”).

The Curriculum and Assessment (Wales) Act 2021 (“the 2021 Act”) establishes a new legal framework for a curriculum and makes provision about assessment for pupils and children in Wales (“the CfW”).

Daw'r Cwricwlwm i Gymru yn fandadol fel a ganlyn—

The CfW will become mandatory as follows—

- (a) ar 1 Medi 2022 ar gyfer—
 - (i) plant sy'n cael addysg feithrin a gyllidir,
 - (ii) disgyblion yn eu blwyddyn derbyn,
 - (iii) plant a disgyblion ym mlynnyddoedd 1 i 6,
- (b) ar 1 Medi 2022 ar gyfer plant a disgyblion ym mlwyddyn 7 yn yr ysgolion hynny a'r lleoliadau eraill hynny pan fo cwricwlwm wedi ei fabwysiadu neu wedi ei ddarparu fel arall yn unol â Deddf 2021,
- (c) ar 1 Medi 2023 ar gyfer plant a disgyblion ym mlynnyddoedd 7 ac 8,
- (d) ar 1 Medi 2024 ar gyfer plant a disgyblion ym mlwyddyn 9,
- (e) ar 1 Medi 2025 ar gyfer plant a disgyblion ym mlwyddyn 10, ac
- (f) ar 1 Medi 2026 ar gyfer plant a disgyblion ym mlwyddyn 11.

- (a) on 1 September 2022 for—
 - (i) children receiving funded nursery education,
 - (ii) pupils in their reception year,
 - (iii) children and pupils in years 1 to 6,
- (b) on 1 September 2022 for children and pupils in year 7 in those schools and other settings where there is a curriculum adopted or otherwise provided in accordance with the 2021 Act,
- (c) on 1 September 2023 for children and pupils in years 7 and 8,
- (d) on 1 September 2024 for children and pupils in year 9,
- (e) on 1 September 2025 for children and pupils in year 10, and
- (f) on 1 September 2026 for children and pupils in year 11.

Mae Rhan 2 o'r Rheoliadau hyn yn gwneud darpariaeth yn barod am y cam cyntaf o gyflwyno'r Cwricwlwm i Gymru i blant a disgyblion yng Nghymru ar 1 Medi 2022 er mwyn diwygio a dirymu nifer o Orchymynion a wnaed o dan adran 108 o Ddeddf Addysg 2002 ("Deddf 2002"). Mae'r Gorchymynion hynny yn gwneud darpariaeth mewn perthynas â'r trefniadau asesu ar gyfer y Cwricwlwm Cenedlaethol presennol a nodir yn Rhan 7 o Ddeddf 2002.

Mae rheoliad 3 o'r Rheoliadau hyn yn dirymu Gorchymyn y Cwricwlwm Cenedlaethol (Trefniadau Asesu Cyfnod Allweddol 2) (Cymru) 2004 ("Gorchymyn 2004") ar 30 Mai 2022. Bydd hyn yn golygu na fydd asesu o dan Orchymyn 2004 yn digwydd yn y flwyddyn ysgol 2021 i 2022. Mae Gorchymyn 2004 yn nodi'r trefniadau asesu ar gyfer blwyddyn olaf yr ail gyfnod allweddol. Mae hynny'n effeithio ar flwyddyn 6. Nid yw'r Cwricwlwm i Gymru yn cael ei gyflwyno i ddisgyblion yn y flwyddyn honno tan y flwyddyn ysgol 2022 i 2023.

Mae Gorchymyn y Cwricwlwm Cenedlaethol (Trefniadau Asesu Cyfnod Allweddol 3) (Cymru) 2005 ("Gorchymyn 2005") yn gwneud darpariaeth ar gyfer asesu disgyblion ym mlwyddyn olaf y trydydd cyfnod allweddol mewn ysgolion a gynhelir yng Nghymru. Mae hynny'n cyfateb i flwyddyn ysgol 9. Bydd y Cwricwlwm Cenedlaethol i Gymru yn cael ei gyflwyno i ddisgyblion sydd ym mlwyddyn ysgol 9 yn y flwyddyn ysgol 2024 i 2025. Mae rheoliad 4(1) yn datgymhwyso Gorchymyn 2005 ar gyfer disgyblion mewn ysgolion arbennig o'r flwyddyn ysgol 2021 i 2022. Mae rheoliad 4(2) yn dirymu Gorchymyn 2005 ar gyfer pob ysgol arall o 1 Medi 2024.

Mae rheoliad 5 yn gwneud darpariaeth drosiannol mewn cysylltiad â Gorchymyn Addysg (Y Cwricwlwm Cenedlaethol) (Trefniadau Asesu ar gyfer Darllen a Rhifedd) (Cymru) 2013 ("Gorchymyn 2013"). Mae Gorchymyn 2013 yn gymwys i'r disgyblion hynny ym mlynnyddoedd 2 i 9. Bydd y profion sy'n ofynnol gan Orchymyn 2013 yn parhau i gael eu gweinyddu gan ysgolion wrth i'r Cwricwlwm newydd i Gymru gael ei gyflwyno i'r blynyddoedd hynny. Yr enw a ddefnyddir yn eang gan ymarferwyr ar gyfer y profion hyn yw "asesiadau personol". Mae'r darpariaethau trosiannol yn diwygio Gorchymyn 2013 fel y bydd yn parhau i weithio gyda'r Cwricwlwm newydd i Gymru. Caiff Gorchymyn 2013 ei ddirymu ar 1 Medi 2024. O 1 Medi 2024 bydd pob disgybl a asesir yn unol â Gorchymyn 2013 yn dilyn y Cwricwlwm i Gymru ac ni fydd angen Gorchymyn 2013 mwyach. Bwriedir gwneud Rheoliadau newydd mewn perthynas â phroffion darllen a rhifedd a fydd yn gymwys o 2024 ymlaen.

Part 2 of these Regulations makes provision in readiness for the first phase of the roll out of the CfW to children and pupils in Wales on 1 September 2022 to amend and revoke a number of Orders made under section 108 of the Education Act 2002 ("the 2002 Act"). Those Orders make provision in relation to the assessment arrangements for the existing National Curriculum set out in Part 7 of the 2002 Act.

Regulation 3 of these Regulations revokes the National Curriculum (Key Stage 2 Assessment Arrangements) (Wales) Order 2004 ("the 2004 Order") on 30 May 2022. This will mean that assessment under the 2004 Order will not take place in the school year 2021 to 2022. The 2004 Order sets out the assessment arrangements for the final year of the second key stage. That affects year 6. The CfW is not rolled out to pupils in that year until the school year 2022 to 2023.

The National Curriculum (Key Stage 3 Assessment Arrangements) (Wales) Order 2005 ("the 2005 Order") makes provision for the assessment of pupils in the final year of the third key stage in maintained schools in Wales. That correlates to school year 9. The CfW will be rolled out to pupils in school year 9 in the school year 2024 to 2025. Regulation 4(1) disapplies the 2005 Order for pupils in special schools from the school year 2021 to 2022. Regulation 4(2) revokes the 2005 Order for all other schools from 1 September 2024.

Regulation 5 makes transitional provision in respect of the Education (National Curriculum) (Assessment Arrangements for Reading and Numeracy) (Wales) Order 2013 ("the 2013 Order"). The 2013 Order applies to those pupils in years 2 to 9. The tests required by the 2013 Order will continue to be administered by schools during the roll out of the new CfW to those years. The tests are widely known by practitioners as the "personalised assessments". The transitional provisions amend the 2013 Order so that it will continue to work with the new CfW. The 2013 Order is revoked on 1 September 2024. From 1 September 2024 all pupils who are assessed pursuant to the 2013 Order will be following the CfW and the 2013 Order will no longer be needed. It is intended to make new Regulations in relation to reading and numeracy tests that will apply from 2024 onwards.

Mae rheoliad 6 yn datgymhwyso Gorchymyn y Cwricwlwm Cenedlaethol (Trefniadau Asesu ar gyfer y Cyfnod Sylfaen a'r Ail Gyfnod Allweddol a'r Trydydd Cyfnod Allweddol) (Cymru) 2014 ("Gorchymyn 2014") i gyd-daro â chyflwyno'r Cwricwlwm newydd i Gymru. Caiff Gorchymyn 2014 ei ddirymu ar 1 Medi 2024. O 1 Medi 2024 bydd pob disgybl a asesir yn unol â Gorchymyn 2014 yn dilyn y Cwricwlwm i Gymru ac ni fydd angen Gorchymyn 2014 mwyach.

Mae rheoliad 7 yn dirymu Gorchymyn y Cwricwlwm Cenedlaethol (Cymedroli Trefniadau Asesu ar gyfer yr Ail Gyfnod Allweddol a'r Trydydd Cyfnod Allweddol) (Cymru) 2015 o 30 Mai 2022.

Mae rheoliad 8 yn dirymu Rhan 4 o Orchymyn y Cwricwlwm Cenedlaethol (Deilliannau Dymunol, Rhaglenni Addysg a Threfniadau Asesu Sylfaenol a Diwedd Cyfnod ar gyfer y Cyfnod Sylfaen) (Cymru) 2015 ("Gorchymyn 2015") ar 30 Mai 2022. Mae Rhan 4 o Orchymyn 2015 yn nodi'r trefniadau asesu ar gyfer blwyddyn olaf y cyfnod sylfaen. Mae hynny'n cyfateb i flwyddyn 2 a bydd y Cwricwlwm i Gymru yn cael ei gyflwyno i ddisgyblion sydd yn y flwyddyn honno yn y flwyddyn ysgol 2022 i 2023. Caiff Gorchymyn 2015 ei ddirymu'n llawn ar 1 Medi 2022.

Mae Rhan 3 o'r Rheoliadau hyn yn diwygio Rheoliadau Adroddiad Pennaeth i Rien i Disgyblion sy'n Oedolion (Cymru) 2011 ("y Rheoliadau Adrodd") a Rheoliadau Gwybodaeth am Berfformiad Ysgolion (Cymru) 2011 ("y Rheoliadau Perfformiad Ysgolion") sy'n ganlyniadol ar ddirymu Gorchymyn 2004 a Gorchymyn 2015.

Mae'r Rheoliadau Adrodd yn gwneud darpariaeth o ran yr adroddiad y mae'n ofynnol i bennaeth ysgol a gynhelir ei anfon at rieni a disgyblion sy'n oedolion bob blwyddyn ysgol a'r wybodaeth ychwanegol y caiff rhiant ofyn i'r pennaeth amdani. Mae rheoliad 10 o'r Rheoliadau hyn yn diwygio'r Rheoliadau Adrodd fel nad yw'n ofynnol i bennaethiaid adrodd ar ganlyniadau'r asesiadau statudol sydd wedi eu dirymu gan y Rheoliadau hyn.

Mae'r Rheoliadau Perfformiad Ysgolion yn rheoleiddio trosglwyddo gwybodaeth sy'n ymwneud â pherfformiad addysgol disgyblion o bennaethiaid i gyrrff llywodraethu ysgolion, awdurdodau lleol a Gweinidogion Cymru. Mae rheoliad 10(1) o'r Rheoliadau hyn yn diwygio'r Rheoliadau Perfformiad Ysgolion er mwyn dileu'r gofyniad ar gorff llywodraethu ysgol a gynhelir i ddarparu canlyniadau'r asesiadau statudol sydd wedi eu dirymu gan y Rheoliadau hyn i'r awdurdod lleol sy'n cynnal yr ysgol ac i Weinidogion Cymru.

Regulation 6 disapplies the National Curriculum (Assessment Arrangements for the Foundation Phase and the Second and Third Key Stages) (Wales) Order 2014 ("the 2014 Order") to coincide with the roll out of the new CfW. The 2014 Order is revoked on 1 September 2024. From 1 September 2024 all pupils who are assessed pursuant to the 2014 Order will be following the CfW and the 2014 Order will no longer be needed.

Regulation 7 revokes the National Curriculum (Moderation of Assessment Arrangements for the Second and Third Key Stages) (Wales) Order 2015 from 30 May 2022.

Regulation 8 revokes Part 4 of the National Curriculum (Desirable Outcomes, Educational Programmes and Baseline and End of Phase Assessment Arrangements for the Foundation Phase) (Wales) Order 2015 ("the 2015 Order") on 30 May 2022. Part 4 of the 2015 Order sets out the assessment arrangements for the final year of the foundation phase. That correlates to year 2 and the CfW will be rolled out to pupils in that year in the school year 2022 to 2023. The 2015 Order is fully revoked on 1 September 2022.

Part 3 of these Regulations makes amendments to the Head Teacher's Report to Parents and Adult Pupils (Wales) Regulations 2011 ("the Reporting Regulations") and the School Performance Information (Wales) Regulations 2011 ("the School Performance Regulations") which are consequential on the revocation of the 2004 Order and the 2015 Order.

The Reporting Regulations make provision as to the report the head teacher of a maintained school is required to send to parents and adult pupils each school year and the additional information a parent may request from the head teacher. Regulation 10 of these Regulations amends the Reporting Regulations so that head teachers are not required to report on the results of the statutory assessments that are revoked by these Regulations.

The School Performance Regulations regulate the transfer of information relating to the educational performance of pupils from head teachers to school governing bodies, local authorities and the Welsh Ministers. Regulation 10(1) of these Regulations amends the School Performance Regulations so as to remove the requirement on a governing body of a maintained school to provide the results of the statutory assessments that are revoked by these Regulations to the local authority that maintains the school and to the Welsh Ministers.

Mae rheoliad 10(2) yn diwygio'r Rheoliadau Perfformiad Ysgolion ymhellach drwy roi Atodlen 2 newydd yn lle'r un bresennol. Effaith hynny yw bod canlyniadau'r profion darllen a rhifedd wedi eu heithrio o'r wybodaeth am asesiadau statudol y mae rhaid i gorff llywodraethu ysgol ei hanfon i'r awdurdod lleol sy'n cynnal yr ysgol honno.

Mae rheoliad 11 yn diwygio rheoliad 5 o Reoliadau Gwybodaeth Ysgolion (Cymru) 2011 er mwyn dileu'r gofyniad i awdurdodau lleol ysgolion ddosbarthu copiâu o'r prospectws cyfansawdd yn ddi-dâl i rieni a disgyblion sydd yn y flwyddyn olaf yn yr ysgol ac a allai drosglwyddo i ysgolion eraill o'r fath.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Regulation 10(2) further amends the School Performance Regulations by substituting a new Schedule 2. The effect of that is that the results of the reading and numeracy tests are excluded from the statutory assessments information that must be sent by a governing body of a school to the local authority that maintains that school.

Regulation 11 amends regulation 5 of the School Information (Wales) Regulations 2011 so as to remove the requirement for school local authorities to distribute copies of the composite prospectus without charge to parents and pupils who are in the final year at the school and might transfer to other such schools.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. 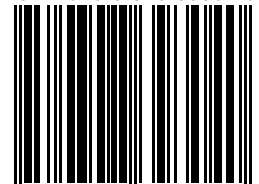
