Mae'r Gorchymyn hwn yn diwygio Rhan 1 o'r Cod Ymddygiad Enghreifftiol fel y'i nodir yn yr Atodlen i Orchymyn Awdurdodau Lleol (Cod Ymddygiad Enghreifftiol) (Cymru) 2008 ("y Gorchymyn") er mwyn ychwanegu cyd-bwyllgorau corfforedig a sefydlir o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (dsc 1) at y rhestr o awdurdodau perthnasol. Effaith y diwygiad fyddai gwneud y Cod Ymddygiad Enghreifftiol gorfodol yn gymwys i aelodau cyd-bwyllgorau corfforedig.

This Order amends Part 1 of the Model Code of Conduct as set out in the Schedule to the Local Authorities (Model Code of Conduct) (Wales) Order 2008 ("the Order") to add corporate joint committees established under Part 5 of the Local Government and Elections (Wales) Act 2021 (asc 1) to the list of relevant authorities. The effect of the amendment would be to make the mandatory Model Code of Conduct applicable to members of corporate joint committees.

Mae'r Cod Ymddygiad Enghreifftiol yn llywodraethu ymddygiad aelodau awdurdodau perthnasol yng Nghymru.

The Model Code of Conduct governs the conduct of the members of relevant authorities in Wales.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r rheoliadau sy'n sefydlu cyd-bwyllgorau corfforedig a gorchmynion a rheoliadau cysylltiedig. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol pan wnaed y rheoliadau sefydlu hynny a dibynnir arno at ddiben y Gorchymyn hwn. The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to the regulations which establish corporate joint committees and connected orders and regulations. As a result, a regulatory impact assessment was prepared at the time of making those establishment regulations and is relied upon for the purpose of this Order. Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd i Gynulliad Cenedlaethol Cymru gan adrannau 50(2) a (3)(1) a 105(2)(a) o Ddeddf Llywodraeth Leol 2000(2) ac a freiniwyd bellach ynddynt hwy, yn gwneud y Gorchymyn hwn.

The Welsh Ministers, in exercise of the powers conferred on the National Assembly of Wales by sections 50(2) and (3)(1) and 105(2)(a) of the Local Government Act 2000(2) and now vested in them, make the following Order.

Yn unol ag adran 49(5) o'r Ddeddf honno, mae Gweinidogion Cymru wedi ymgynghori ag Archwilydd Cyffredinol Cymru, Ombwdsmon Gwasanaethau Cyhoeddus Cymru, cynrychiolwyr awdurdodau perthnasol, a'r personau eraill hynny yr oeddent yn ystyried eu bod yn briodol.

In accordance with section 49(5) of that Act, the Welsh Ministers have consulted the Auditor General for Wales, the Public Services Ombudsman for Wales, representatives of relevant authorities, and such other persons as considered appropriate.

**1.**—(1) Enw'r Gorchymyn hwn yw Gorchymyn Awdurdodau Lleol (Cod Ymddygiad Enghreifftiol) (Cymru) (Diwygio) 2022.

(2) Daw'r Gorchymyn hwn i rym ar 5 Awst 2022.

**Title and coming into force**

**1.**—(1) The title of this Order is The Local Authorities (Model Code of Conduct) (Wales) (Amendment) Order 2022.

(2) This Order comes into force on 5 August 2022.

2. Yn y diffiniad o “awdurdod perthnasol” yn Rhan 1 (*Dehongli*) o'r Atodlen i Orchymyn Awdurdodau Lleol (Cod Ymddygiad Enghreifftiol) (Cymru) 2008(1) ar ôl “cyngor cymuned” mewnosoder—

“(ca) cyd-bwyllgor corfforedig a sefydlir gan reoliadau a wnaed o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (dsc 1)(2).”.

**Amendment of the Schedule to the Local Authorities (Model Code of Conduct) (Wales) Order 2008**

2. In the definition of “relevant authority” in Part 1 (*Interpretation*) of the Schedule to the Local Authorities (Model Code of Conduct) (Wales) Order 2008(1) after “a community council” insert—

“(ca) a corporate joint committee established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021 (asc 1)(2).”.

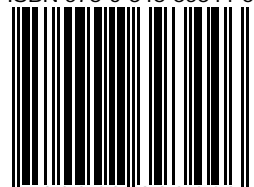
