Mae'r SASW yn pennu'r gofynion y mae rhaid eu bodloni er mwyn i fframweithiau prentisiaethau Cymreig cydnabyddedig gael eu dyroddi o dan adran 19(1) o Ddeddf 2009.

Mae'r addasiadau a wneir gan y Gorchymyn hwn yn cynnwys sicrhau hygyrchedd ar gyfer y rheini sydd ag anhawster neu anabledd dysgu.

Er mwyn helpu'r darllenynnad mae Gweinidogion Cymru wedi cyhoeddi fersiwn wedi ei chydgrynhau o'r SASW sy'n ymgorffori'r addasiadau a ddangosir yn yr Atodlen i'r Gorchymyn hwn.

The Apprenticeships (Specification

EXPLANATORY NOTE

(This note is not part of the Order)

This Order is made under section 29(1) of the Apprenticeships, Skills, Children and Learning Act 2009 ("the 2009 Act"). This Order modifies the Specification of Apprenticeship Standards for Wales ("the SASW") which was originally brought into effect in May 2013 by the Apprenticeships (Specification of Apprenticeship Standards for Wales) Order 2013, and subsequently modified in 2016 by the Apprenticeships (Specification of Apprenticeship Standards for Wales) (Modification) Order 2016.

The SASW specifies the requirements that must be met for recognised Welsh apprenticeship frameworks to be issued under section 19(1) of the 2009 Act.

The modifications made by this Order include ensuring accessibility for those with a learning difficulty or disability.

To assist the reader the Welsh Ministers have published a consolidated version of the SASW which incorporates the modifications shown in the Schedule to this Order.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

The Welsh Ministers make the following Order in exercise of the power conferred by section 29(1) of the Apprenticeships, Skills, Children and Learning Act 2009(1).

In accordance with section 29(2) of that Act the Welsh Ministers are satisfied that the Specification of Apprenticeship Standards for Wales as modified by this Order complies with section 31.

Title and coming into force

1. The title of this Order is the Apprenticeships (Specification of Apprenticeship Standards for Wales) (Modification) Order 2023 and it comes into force on 11 December 2023.

Interpretation

2. In this Order, "the Specification of Apprenticeship Standards for Wales" means the document given effect by article 2 of the Apprenticeships (Specification of Apprenticeship Standards for Wales) Order 2013(2).

Addasiadau i Fanylob Safonau Prentisiaethau Cymru

1. Yn lle paragraff 1 rhodder—

“1. Mae Manyleb Safonau Prentisiaethau Cymru (“SASW”) yn nodi’r gofynion sylfaenol i’w cynnwys mewn fframwaith prentisiaeth Cymreig cydnabyddedig. Mae cydymffurfio â’r SASW yn un o ofynion statudol Deddf Prentisiaethau, Sgiliau, Plant a Dysgu 2009. Mae’r fersiwn hon yn ymgorffori’r addasiadau a wnaed i’r SASW wreiddiol a gyhoeddwyd ym mis Mai 2013 a’r addasiadau a wnaed yn 2016.

Mae’n ymgorffori addasiadau er mwyn caniatáu cymwysterau “prosci” ychwanegol fel dewis arall cydnabyddedig yn lle Sgiliau Hanfodol fel y manylir arnynt o dan bob lefel fframwaith prentisiaeth, ac mae’n cynnwys cynnig mwy cynhwysol i bobl ag anawsterau ac anableddau dysgu er mwyn ehangu cyfranogiad, gan agror y gofynion mynediad o ran sgiliau hanfodol ar gyfer lefelau 2 a 3.

Mae’n cynnwys adran newydd ar brentisiaethau gradd a phroffesiynol (lefelau 6 a 7), sy’n dileu’r gofynion o ran sgiliau hanfodol ar gyfer prentisiaethau ar y lefel hon.

Mae canllawiau cyfredol wedi eu cyhoeddi mewn dogfen ar wahân. Rhaid i Awdurdodau Cyhoeddi Cymru roi sylw i’r canllawiau cyfredol hyn wrth wneud penderfyniad ynghylch a yw cyflwyniad fframwaith yn cydymffurfio â’r SASW.

Mae’r addasiadau i’r SASW wedi eu gwneud drwy orchymyn gan Weinidogion Cymru.”

2. Yn lle paragraff 2 rhodder—

“2. Rhaid i fframwaith prentisiaeth bennu ei lefel gan ddefnyddio’r disgrifyddion lefel cenedlaethol a ddisgrifir yn Fframwaith Credydau a Chymwysterau Cymru (“FfCChC”).”

3. Yn lle paragraff 3 rhodder—

“3. Rhaid i fframwaith fod ar Lefel 2 i fod yn gymwys fel Prentisiaeth Sylfaen, ar Lefel 3 i fod yn gymwys fel Prentisiaeth, ar Lefel 4 neu 5 i fod yn gymwys fel Prentisiaeth Uwch ac ar Lefel 6 neu 7 i fod yn gymwys fel Prentisiaeth Gradd neu Broffesiynol.”

Modifications to the Specification of Apprenticeship Standards for Wales

1. For paragraph 1 substitute—

“1. The Specification of Apprenticeship Standards for Wales (“SASW”) sets out the minimum requirements to be included in a recognised Welsh apprenticeship framework. Compliance with the SASW is a statutory requirement of the Apprenticeship, Skills, Children and Learning Act 2009. This version incorporates modifications made to the original SASW published in May 2013 and modifications made in 2016.

It incorporates modifications to allow additional “proxy” qualifications as a recognised alternative to Essential Skills as detailed under each apprenticeship framework level, and includes a more inclusive offer for people with learning difficulties and disabilities to widen participation, opening up the essential skills entry requirements for levels 2 and 3.

It includes a new section on degree and professional apprenticeships (levels 6 and 7), which removes the essential skills requirements for apprenticeships at this level.

Updated guidance has been issued in a separate document. The Welsh Issuing Authorities must have regard to this updated guidance in reaching a decision on whether a framework submission complies with SASW.

The modifications to SASW have been made by order by the Welsh Ministers.”

2. For paragraph 2 substitute—

“2. An apprenticeship framework must specify its level using the national level descriptors described in the Credit and Qualifications Framework for Wales (“CQFW”).”

3. For paragraph 3 substitute—

“3. A framework must be at Level 2 to qualify as a Foundation Apprenticeship, be at Level 3 to qualify as an Apprenticeship, be at Level 4 or 5 to qualify as a Higher Apprenticeship and Level 6 or 7 to qualify as a Degree or Professional Apprenticeship.”

4. Yn lle paragraff 6 rhodder—

“**6.** Rhaid i fframwaith fod yn 38 o gredydau o leiaf, heb gynnwys credydau sgiliau hanfodol, ond pan fo'n briodol, gall fod yn fwy na hyn; mewn sawl achos bydd fframweithiau gryn dipyn yn fwy na 38 o gredydau. Ni all fframwaith fod mor gul fel nad yw ond yn berthnasol i weithle penodol lle yr enillwyd y brentisiaeth.”

5. Yn lle paragraff 10 rhodder—

“**10.** Bydd y datblygwr fframwaith yn penderfynu ar gydbwysedd y credydau rhwng cymwyseddau galwedigaethol a chymwysterau gwybodaeth dechnegol perthnasol. Fodd bynnag, rhaid i'r fframwaith bennu:

- (a) o leiaf 19 o gredydau a gyflawnwyd o gymhwyster ar sail cymhwysedd galwedigaethol neu elfen cymhwysedd cymhwyster integredig, sy'n ymwneud yn benodol â'r sgil, y fasnach neu'r alwedigaeth ac sy'n seiliedig ar y Safonau Galwedigaethol Cenedlaethol (SGC) lle y maent yn bodoli, neu safonau ar gyfer y diwydiant cyfan neu, lle nad ydynt yn bodoli, safonau proffesiynol ar gyfer y sector cyflogaeth y lluniwyd y fframwaith ar ei gyfer a rhaid iddo fod ar lefel sy'n adlewyrchu rôl y swydd; a
- (b) o leiaf 19 o gredydau a gyflawnwyd o gymhwyster gwybodaeth dechnegol neu elfen gwybodaeth cymhwyster integredig sy'n darparu'r wybodaeth dechnegol a'r ddealltwriaeth o'r cysyniadau damcaniaethol sy'n ymwneud yn benodol â'r sgil, y fasnach neu'r alwedigaeth i ategu cymhwysedd galwedigaethol. Rhaid i'r elfen cymhwyster gwybodaeth roi'r wybodaeth a'r ddealltwriaeth o'r diwydiant a'i farchnad i'r prentis; neu
- (c) o leiaf 19 o gredydau o gymhwyster cymwyseddau cyfatebol (nad ydynt yn rhai FfCChC) a gydnabyddir gan gorff proffesiynol ar gyfer Prentisiaeth Uwch ar Lefelau 4 neu 5 a Phrentisiaethau Gradd neu Broffesiynol Lefelau 6 neu 7 pan fo cwblhau prentisiaeth o'r fath yn llwyddiannus yn llwybr cydnabyddedig at gofrestru proffesiynol.”

4. For paragraph 6 substitute—

“**6.** A framework must be a minimum of 38 credits, excluding essential skills credits, but may, where appropriate, exceed this; in many cases frameworks will significantly exceed 38 credits. A framework must not be so narrow that it is only relevant to a specific workplace where the apprenticeship was attained.”

5. For paragraph 10 substitute—

“**10.** The framework developer will decide the balance of credits between occupational competencies and relevant technical knowledge qualifications. However, the framework must specify:

- (a) a minimum of 19 credits achieved from an occupational competence-based qualification or the competence element of an integrated qualification, which specifically relates to the skill, trade or occupation and is based on the National Occupational Standards (NOS) where they exist, or industry-wide standards or, where they do not, professional standards for the employment sector for which the framework is designed and be at a level which reflects the job role; and
- (b) a minimum of 19 credits achieved from a technical knowledge qualification or knowledge element of an integrated qualification which provides the technical knowledge and understanding of the theoretical concepts specifically relating to the skill, trade or occupation to underpin occupational competence. The knowledge qualification element must equip the apprentice with the knowledge and understanding of the industry and its market; or
- (c) a minimum of 19 credits from an equivalent competencies qualification (non-CQFW) recognised by a professional body for a Higher Apprenticeship at Levels 4 or 5 and Degree or Professional Apprenticeships Levels 6 or 7 where the successful completion of such an apprenticeship is a recognised pathway to professional registration.”

6. Yn lle is-baragraff 11(b) rhodder—

“(b) y cynnwys dysgu o gymhwyster cymwyseddau cyfatebol a gydnabyddir gan gorff proffesiynol ar gyfer Prentisiaeth Uwch a Phrentisiaeth Gradd a Phroffesiynol, pan fo cwblhau prentisiaeth o'r fath yn llwybr cydnabyddedig at gofrestru proffesiynol.”

7. Ar ôl paragraff 16 mewnosoder—

“16A. Mae'n bosibl y bydd rhai prentisiaid ag anhawster dysgu neu anabledd dysgu yn gallu cyrraedd y safon alwedigaethol ond y byddant yn ei chael hi'n anodd cyflawni'r cymhwyster mewn Saesneg neu fathemateg ar y lefel sy'n ofynnol fel arfer. Disgwylir i ddarparwyr barhau i wneud pob ymdrech i helpu prentisiaid i gyrraedd y safonau hyn.

Fodd bynnag, gan gydnabod y rhwystrau i gyfranogiad y gall y gofynion hyn eu peri i berson ag anhawster neu anabledd dysgu, caniateir eithriadau ar gyfer prentisiaethau sylfaen a phrentisiaethau i'r gofynion sylfaenol ar gyfer Saesneg a mathemateg.

Bydd rhesymoldeb yr addasiad sydd i'w wneud yn dibynnu ar amgylchiadau unigol y prentis a'i asesiad. Gall yr addasiad fod yn gymwys i un pwnc, neu i Saesneg a mathemateg ill dwy. Os nad yw'r addasiad ond yn cael ei gymhwysio i un pwnc, bydd y gofynion arferol ar gyfer y pwnc nas addaswyd yn parhau i fod yn gymwys. Gall y darparwr ystyried addaswyr gofynion sylfaenol am Sgiliau Hanfodol mewn Cyfathrebu a Chymhwyso Rhif fesul achos unigol pan fo'r **holl** amodau a ganlyn wedi eu bodloni:

Mae gan y prentis naill ai fersiwn gyfredol neu fersiwn a ddyroddwyd yn flaenorol o Gynllun Datblygu Unigol (CDU), datganiad o Anghenion Addysgol Arbennig (AAA), Cynllun Addysg, Iechyd a Gofal (AIG), neu Gynllun Dysgu a Sgiliau (CDS);

Cynhelir asesiad â thystiolaeth sy'n dangos nad yw'r prentis, hyd yn oed gyda chymorth ac addasiadau, yn gallu cyflawni Saesneg neu fathemateg i'r lefel ofynnol o ganlyniad i'w anhawster dysgu neu ei anabledd dysgu;

6. For sub-paragraph 11(b) substitute—

“(b) the learning content from an equivalent competencies qualification recognised by a professional body for a Higher Apprenticeship and a Degree and Professional Apprenticeship, where the successful completion of such an apprenticeship is a recognised pathway to professional registration.”

7. After paragraph 16 insert—

“16A. Some apprentices with a learning difficulty or learning disability may be able to meet the occupational standard but may struggle to achieve the English or maths qualification at the level normally required. Providers are expected to continue to make every effort to help apprentices meet these standards.

However, in recognition of the barriers to participation these requirements may present to a person with a learning difficulty or disability, exceptions for foundation apprenticeships and apprenticeships will be permitted to the English and maths minimum requirements.

The reasonableness of the adjustment to be made will depend on the apprentice's individual circumstances and assessment. The adjustment may apply to one subject, or to both English and maths. If the adjustment is only applied to one subject, the regular requirements for the non-adjusted subject will continue to apply. Adjusting the minimum requirements to Essential Communication Skills and Essential Application of Number Skills can be considered by the provider on an individual case-by-case basis where **all** the following conditions have been satisfied:

The apprentice has either an existing or previously issued Individual Development Plan (IDP), a statement of Special Educational Needs (SEN), Education, Health and Care (EHC) Plan, or a Learning and Skills Plan (LSP);

An evidenced assessment is undertaken demonstrating that even with support and adjustments the apprentice is not able to achieve English or maths to the minimum level as a result of their learning difficulty or disability;

Rhaid i'r cyflogwr a'r darparwr ddisgwyd yn rhesymol y bydd y prentis yn gallu chyflawni'n llwyddianus bob agwedd arall ar ofynion y brentisiaeth, dod yn gymwys yn alwedigaethol a chyflawni Sgiliau Hanfodol mewn Cyfathrebu a Sgiliau Hanfodol mewn Cymhwys Rhif yn y pynciau a addaswyd cyn diwedd ei brentisiaeth; ac

Nid oes unrhyw ofynion mynediad sylfaenol ar gyfer y diwydiant penodol hwnnw."

8. Yn lle paragraff 19 rhodder—

“**19.** Gall fframwaith Prentisiaeth Uwch ar Lefelau 4 neu 5 neu Brentisiaeth Gradd neu Broffesiynol Lefelau 6 neu 7 bennu cymwysterau proffesiynol ychwanegol fel y'u cydnabyddir gan y sector os ydynt yn rhoi cymhwystra ar gyfer statws proffesiynol.”

9. Yn lle paragraff 24 rhodder—

“**24.** Gall fframwaith prentisiaeth sylfaen bennu fel un o ofynion dystysgrif Cymru gymhwyster mewn Sgiliau Hanfodol mewn Llythrenedd Digidol i Lefel 1 o leiaf, oni fydd Llythrenedd Digidol yn amherthnasol i berfformiad effeithiol yn y sgil, y fasnach neu'r alwedigaeth y mae'r fframwaith yn ymwned ag ef/â hi. Fodd bynnag, caniateir eithriadau mewn cysylltiad â phrentisiaid ag anawsterau dysgu neu anabledd dysgu fel yr amlinellir ym mharagraff 16A.”

10. Ar ôl paragraff 25 mewnosoder—

“**25A.** Gall yr awdurdod dyroddi, yn ôl ei ddisgresiwn, bennu mewn fframwaith y derbynir cymwysterau rheoleiddiedig sy'n cyfateb i'r cymwysterau procsi a restrir yn y SASW ar gyfer Sgiliau Hanfodol mewn Cyfathrebu a Chymhwys Rhif neu sydd ar lefel uwch na'r cymwysterau procsi hynny. Rhaid i unrhyw cymwysterau o'r fath roi dystiolaeth bod y cymwyseddau a asesir yn y cymwysterau Sgiliau Hanfodol mewn cyfathrebu a rhif wedi eu cwblhau.

The employer and provider must reasonably expect that the apprentice will be able to successfully achieve all other aspects of the apprenticeship requirements, become occupationally competent and achieve Essential Communication Skills and Essential Application of Number Skills in the adjusted subjects before the end of their apprenticeship; and

There are no industry specific minimum entry requirements.”

8. For paragraph 19 substitute—

“**19.** A Higher Apprenticeship framework at Levels 4 or 5 or a Degree or Professional Apprenticeship Levels 6 or 7 may specify additional professional qualifications as recognised by the sector if they confer eligibility for professional status.”

9. For paragraph 24 substitute—

“**24.** A foundation apprenticeship framework may specify as a Welsh certificate requirement a qualification in Essential Digital Literacy Skills to at least Level 1, unless Digital Literacy is not relevant to effective performance in the skill, trade or occupation to which the framework relates. However, exceptions will be permitted for apprentices with learning difficulties or a learning disability as outlined in paragraph 16A.”

10. After paragraph 25 insert—

“**25A.** The issuing authority may at their discretion specify in a framework the acceptance of regulated qualifications that are equivalent or at a higher level to the proxies listed in SASW for Essential Skills in Communication and Application of Number. Any such qualifications must evidence completion of the competencies being assessed in the Essential Skills qualifications in communication and number.
