Mae'r Rheoliadau hyn yn pennu dyddiad diwygiedig ar gyfer diwedd y cyfnod y mae rhaid i fersiynau diwygiedig y cofrestrau o etholwyr llywodraeth leol yng Nghymru, am y flwyddyn 2024, gael eu cyhoeddi ynddo gan swyddogion cofrestru o dan adran 13(1)(a) o Ddeddf Cynrychiolaeth y Bobl 1983 ("Ddeddf 1983").

Mae rheoliad 2(1) yn gymwys i gyhoeddi gan swyddog cofrestru (gweler adran 8 o Ddeddf 1983) ar gyfer ardal sirol neu ardal bwrdeistref sirol yng Nghymru y gofrestr ddiwygiedig o etholwyr llywodraeth leol a gynhelir gan y swyddog hwnnw o dan adran 9(1)(b) o Ddeddf 1983.

Mae rheoliad 2(2) yn pennu'r dyddiad erbyn pryd y mae rhaid i'r gofrestr honno gael ei chyhoeddi yn 1 Chwefror 2025.

Er mwyn sicrhau cysondeb wrth gyhoeddi'r cofrestrau etholiadol yng Nghymru, mae Rheoliadau Cynrychiolaeth y Bobl (Diwygio'r Etholfraint ac Adolygu Cymhwystera) 2023 (O.S. 2023/1150) yn rhagnodi'r dyddiad 1 Chwefror 2025 ar gyfer cyhoeddi gan swyddogion cofrestru fersiynau diwygiedig y cofrestrau o etholwyr seneddol y Deyrnas Unedig a gynhelir ar gyfer ardaloedd yng Nghymru, am y flwyddyn 2024, o dan adran 9(1)(a) o Ddeddf 1983.

REPRESENTATION OF THE PEOPLE, WALES

The Representation of the People
(Electoral Registers Publication
Date) (Wales) Regulations 2023

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations set a revised date for the end of the period during which the revised versions of the registers of local government electors in Wales, for the year 2024, must be published by registration officers under section 13(1)(a) of the Representation of the People Act 1983 ("the 1983 Act").

Regulation 2(1) applies to the publication by a registration officer (see section 8 of the 1983 Act) for a county or county borough area in Wales of the revised register of local government electors maintained by that officer under section 9(1)(b) of the 1983 Act.

Regulation 2(2) sets the date by which that register must be published as 1 February 2025.

To ensure consistency in the publication of the electoral registers in Wales, the Representation of the People (Franchise Amendment and Eligibility Review) Regulations 2023 (S.I. 2023/1150) prescribe the date of 1 February 2025 for the publication by registration officers of the revised versions of the registers of United Kingdom parliamentary electors maintained for areas in Wales, for the year 2024, under section 9(1)(a) of the 1983 Act.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations as they implement a technical amendment which has no impact, or no significant, impact on the private, voluntary or public sectors.

The Representation of the People
(Electoral Registers Publication
Date) (Wales) Regulations 2023

Made	6 December 2023
Coming into force	11 December 2023

The Welsh Ministers make the following Regulations in exercise of the power conferred on the Secretary of State by sections 13(1)(a) and 201(1) and (3) of the Representation of the People Act 1983(1) ("the 1983 Act") and now exercisable by them(2).

The Welsh Ministers have consulted the Electoral Commission in accordance with section 7(1) and (2)(e) of the Political Parties, Elections and Referendums Act 2000(3).

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cynrychiolaeth y Bobl (Dyddiad Cyhoeddi'r Cofrestrau Etholiadol) (Cymru) 2023.

(2) Daw'r Rheoliadau hyn i rym ar 11 Rhagfyr 2023.

(3) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(4) Yn y Rheoliadau hyn, ystyr "Deddf 1983" yw Deddf Cynrychiolaeth y Bobl 1983.

Dyddiad cyhoeddi'r cofrestrau diwygiedig am y flwyddyn 2024

2.—(1) Mae'r rheoliad hwn yn gymwys i'r gofyniad o dan adran 13(1)(a) o Deddf 1983 i swyddogion cofrestru gyhoeddi, am y flwyddyn 2024, fersiynau diwygiedig y cofrestrau a gynhelir o dan adran 9(1)(b) o Deddf 1983(3).

(2) Y dyddiad ar gyfer diwedd y cyfnod a ddisgrifir yn adran 13(1)(a) o Deddf 1983, sef y cyfnod y mae rhaid i'r cofrestrau diwygiedig gael eu cyhoeddi yn ddi, yw 1 Chwefror 2025.

A draft of these Regulations was laid before, and approved by resolution of Senedd Cymru in accordance with section 201(2)(1) of the 1983 Act(2).

Title, commencement, application and interpretation

1.—(1) The title of these Regulations is the Representation of the People (Electoral Registers Publication Date) (Wales) Regulations 2023.

(2) These Regulations come into force on 11 December 2023.

(3) These Regulations apply in relation to Wales.

(4) In these Regulations, "the 1983 Act" means the Representation of the People Act 1983.

Date for publication of revised registers for the year 2024

2.—(1) This regulation applies to the requirement under section 13(1)(a) of the 1983 Act for registration officers to publish, for the year 2024, revised versions of the registers maintained under section 9(1)(b) of the 1983 Act(3).

(2) The date for the end of the period described in section 13(1)(a) of the 1983 Act, being the period during which the revised registers must be published, is 1 February 2025.
