The Social Partnership and Public Procurement (Wales) Act 2023
(Commencement No. 1) Order 2023

EXPLANATORY NOTE

(*This note is not part of the Order*)

This Order made by the Welsh Ministers brings into force certain provisions of the Social Partnership and Public Procurement (Wales) Act 2023 (asc 1) ("the Act").
