Mae'r Rheoliadau hyn wedi eu gwneud drwy arfer y pwerau a roddir gan baragraff 11A(1) o Atodlen 2 i Reoliadau'r Fasnach mewn Anifeiliaid a Chynhyrchion Perthynol (Cymru) 2011 (O.S. 2011/2379) (Cy. 252).

These Regulations are made in exercise of the powers conferred by paragraph 11A(1) of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011 (S.I. 2011/2379) (W. 252).

Mae rheoliad 2 yn diwygio Rheoliadau Paratoadau Cig (Diwygio ac Addasiadau Darfodol) (Cymru) (Ymadael â'r UE) 2021 (O.S. 2021/1 (Cy. 1)) er mwyn estyn yr ataliad dros dro ar y gofyniad i baratoadau cig fod wedi eu rhewi'n ddwfn pan fônt yn cael eu mewnfario i Gymru o Aelod-wladwriaethau'r AEE, Ynysoedd Ffaro, yr Ynys Las neu'r Swistir, gan gysoni â'r dyddiad a benodwyd yn ddyddiad dod i ben estynedig y "cyfnod graddoli trosiannol", a ddiffinnir yn Atodiad 6 i Reoliad (EU) 2017/625 (EUR 2017/625). Mae'r estyniad hwn hyd 29 Ebrill 2024.

Regulation 2 amends the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) Regulations 2021 (S.I. 2021/1 (W. 1)) to extend the temporary suspension of the requirement for meat preparations to be deep frozen where they are imported into Wales from EEA member States, the Faroe Islands, Greenland or Switzerland, bringing it into line with the date appointed as the extended end date of the "transitional staging period", defined in Annex 6 to Regulation (EU) 2017/625 (EUR 2017/625). This extension is until 29 April 2024.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers make the following Regulations in exercise of the powers conferred by paragraph 11A(1) of Schedule 2 to the Trade in Animals and Related Products (Wales) Regulations 2011(1).

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Paratoadau Cig (Diwygio ac Addasiadau Darfodol) (Cymru) (Diwygio) 2024.

(2) Daw'r Rheoliadau hyn i rym ar 30 Ionawr 2024.

**Title and commencement**

1.—(1) The title of these Regulations is the Meat Preparations (Amendment and Transitory Modification) (Wales) (Amendment) Regulations 2024.

(2) These Regulations come into force on 30 January 2024.

2. In regulation 3(1) (transitory modification of Commission Decision 2000/572/EC) of the Meat Preparations (Amendment and Transitory Modification) (Wales) (EU Exit) Regulations 2021(2), for "31 January" substitute "29 April".
