# Rheoliadau Adeiladu (Diwygio) (Cymru) 2024

#### NODYN ESBONIADOL

#### (Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Adeiladu 2010 ("Rheoliadau 2010") fel y maent yn gymwys o ran Cymru. Mae Rheoliadau 2010 yn cynnwys gofynion i osod systemau llethu tân awtomatig mewn cartrefi gofal i oedolion. Cyn i'r Rheoliadau hyn gael eu deddfu darparwyd y gofynion i osod systemau llethu tân awtomatig mewn cartrefi gofal i blant yng Nghymru ym Mesur Diogelwch Tân Domestig (Cymru) 2011 (mccc 2) ("Mesur 2011"). Bydd y Rheoliadau hyn yn symud y gofyniad mewn cysylltiad â chartrefi gofal i blant i Reoliadau 2010.

Mae rheoliad 2(2) yn diwygio paragraff (b) o'r diffiniad o "institution" yn rheoliad 2 (dehongli) o Reoliadau 2010 i ddarparu bod sefydliad a ddefnyddir ar gyfer personau o dan 18 oed yn dod o fewn y diffiniad hwnnw. Cyn i'r Rheoliadau hyn gael eu deddfu, dim ond personau o dan bump oed a oedd wedi eu cynnwys yn y diffiniad o "institution".

Mae rheoliad 2(3)(a) yn diwygio rheoliad 37A (darparu systemau llethu tân awtomatig) o Reoliadau 2010 i fewnosod gofyniad i osod systemau llethu tân awtomatig mewn cartrefi gofal i blant pan fyddant newydd eu codi, neu pan fo gwaith adeiladu yn arwain at newid defnydd sylweddol. # BUILDING AND BUILDINGS, WALES

The Building (Amendment) (Wales) Regulations 2024

#### **EXPLANATORY NOTE**

#### (This note is not part of the Regulations)

These Regulations amend the Building Regulations 2010 ("the 2010 Regulations") as they apply in relation to Wales. The 2010 Regulations include requirements for automatic fire suppression systems to be installed in care homes for adults. Prior to the enactment of these Regulations the requirements for automatic fire suppression systems to be installed in care homes for children in Wales were provided in the Domestic Fire Safety (Wales) Measure 2011 (nawm 3) ("the 2011 Measure"). These Regulations will move the requirement in respect of care homes for children to the 2010 Regulations.

Regulation 2(2) amends paragraph (b) of the definition of "institution" in regulation 2 (interpretation) of the 2010 Regulations to provide that an institution which is used for persons under the age of 18 falls within that definition. Prior to the enactment of these Regulations, only persons under the age of five years were included in the definition of "institution".

Regulation 2(3)(a) amends regulation 37A (provision of automatic fire suppression systems) of the 2010 Regulations to insert a requirement for automatic fire suppression systems to be installed in care homes for children when they are newly erected, or where building work results in a material change of use. This requirement replicates the existing provision in the 2011 Measure.

Mae rheoliad 2(3)(b) yn darparu bod newid defnydd sylweddol mewn adeilad, at ddibenion rheoliad 37A, yn cynnwys newid defnydd sylweddol o gartref gofal i blant i gartref gofal i oedolion neu o gartref gofal i oedolion i gartref gofal i blant. Mae paragraff (2A) sydd newydd ei fewnosod yn cadarnhau na fydd y gofynion a osodir gan reoliad 6 o Reoliadau 2010 yn gymwys i newid defnydd sylweddol o'r fath.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Regulation 2(3)(b) provides that for the purposes of regulation 37A a material change of use in a building includes a material change of use from a care home for children to a care home for adults or from a care home for adults to a care home for children. The newly inserted paragraph (2A) confirms the requirements set by regulation 6 of the 2010 Regulations will not apply to such a material change of use.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. ## The Building (Amendment) (Wales) Regulations 2024

Made	7 June 2024
Laid before Senedd Cymru	11 June 2024

Coming into force

17 December 2024

The Welsh Ministers make the following Regulations in exercise of the powers conferred on the Secretary of State by sections 1 and 34 of, and paragraphs 7, 8 and 10 of Schedule 1 to, the Building Act 1984(1), now exercisable by them(2).

In making these Regulations the Welsh Ministers have regard to the matters in section 1A(**3**) of that Act and before making these Regulations the Welsh Ministers consulted the Building Regulations Advisory Committee for Wales and such other persons as

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Adeiladu (Diwygio) (Cymru) 2024.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(3) Daw'r Rheoliadau hyn i rym ar 17 Rhagfyr 2024.

#### Diwygio Rheoliadau Adeiladu 2010

**2.**—(1) Mae Rheoliadau Adeiladu 2010(**2**) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2 (dehongli) yn y diffiniad o "institution", ym mharagraff (b), yn lle "under the age of five years" rhodder "under the age of 18".

(3) Yn rheoliad 37A(3) (darparu systemau llethu tân awtomatig)—

- (a) ym mharagraff (1), ar ôl is-baragraff (a) mewnosoder—
  - "(aa) care homes for children, which means places at which a care home service, within the meaning of Part 1 of the Regulation and Inspection of Social Care (Wales) Act 2016(4), is provided wholly or mainly to persons aged under 18, but not—
    - (i) an institution within the further education sector as defined by section 91(3) of the Further and Higher Education Act 1992(5);
    - (ii) a place at which accommodation is provided for the purposes of—
      - (aa) a holiday;
      - (bb) a leisure, recreational, sporting, cultural or educational activity;

appeared to them to be appropriate in accordance with section 14(7) of the Building Act 1984(1).

#### Title, application, and coming into force

**1.**—(1) The title of these Regulations is the Building (Amendment) (Wales) Regulations 2024.

(2) These Regulations apply in relation to Wales.

(3) These Regulations come into force on 17 December 2024.

#### Amendment of the Building Regulations 2010

**2.**—(1) The Building Regulations 2010(**2**) are amended as follows.

(2) In regulation 2 (interpretation) in the definition of "institution", in paragraph (b), for "under the age of five years" substitute "under the age of 18".

(3) In regulation 37A(**3**) (provision of automatic fire suppression systems)—

- (a) in paragraph (1), after sub-paragraph (a) insert—
  - "(aa) care homes for children, which means places at which a care home service, within the meaning of Part 1 of the Regulation and Inspection of Social Care (Wales) Act 2016(4), is provided wholly or mainly to persons aged under 18, but not—
    - (i) an institution within the further education sector as defined by section 91(3) of the Further and Higher Education Act 1992(5);
    - (ii) a place at which accommodation is provided for the purposes of—
      - (aa) a holiday;
      - (bb) a leisure, recreational, sporting, cultural or educational activity;
