(Amendment) Regulations 2024**

**NODYN ESBONIADOL**

*(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)*

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Rhestr Ardrethu Canolog (Cymru) 2005 ("Rheoliadau 2005"). Mae Rheoliadau 2005 yn dynodi personau ac yn rhagnodi, mewn perthynas â'r personau hynny, un neu ragor o ddisgrifiadau o hereditamentau annomestig. Mae'r diwygiadau a wneir gan y Rheoliadau hyn yn adlewyrchu enwau newydd personau dynodedig penodol, ac yn dileu'r rhai nad ydynt yn atebol mwyach am hereditamentau annomestig penodol. Mae rhifau cwmni ar gyfer pob person dynodedig wedi eu mewnosod hefyd. Yr effaith yw sicrhau bod Rheoliadau 2005 yn adlewyrchu'n gywir y personau dynodedig, a'r disgrifiadau cyfatebol o hereditamentau, ar Restr Ardrethu Ganolog Cymru.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the Central Rating List (Wales) Regulations 2005 ("the 2005 Regulations"). The 2005 Regulations designate persons and prescribe, in relation to those persons, one or more descriptions of non-domestic hereditament. The amendments made by these Regulations reflect the change of name of certain designated persons, and remove those who are no longer liable for certain non-domestic hereditaments. Company numbers for each designated person are also inserted. The effect is to ensure the 2005 Regulations accurately reflect the designated persons and the corresponding descriptions of hereditaments on the Central Rating List for Wales.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers make these Regulations in exercise of the powers conferred on the Secretary of State by section 53(1) of the Local Government Finance Act 1988(1), and now vested in them(2).

**Title and coming into force**

1.—(1) The title of these Regulations is the Central Rating List (Wales) (Amendment) Regulations 2024.

(2) These Regulations come into force on 18 July 2024.
